# \*1. GARY A. ROGERS – CONDITIONAL USE PERMIT (CUP #2017-029), – MADERA (DISTRICT 5) LEAD PLANNER: EMILY LANE

Gary A. Rogers is requesting a Conditional Use Permit (CUP #2017-029) to allow proposed staff housing for the existing Camp Sugar Pine. The property is owned by Sugar Pine Christian Camps and is located on the north side of Mill Canyon Road, approximately 1.02 mile north of Road 630 (48478 Mill Canyon Road), Oakhurst. The property is zoned RMS (Residential, Mountain, Single Family) and POS (Public Open Space) Districts. A draft Mitigated Negative Declaration (MND #2017-37) has been prepared concerning the proposed project in compliance with provisions of the California Environmental Quality Act (CEQA). ## \*2. BOB SHOCKLEY – CONDITIONAL USE PERMIT (CUP #2017-028) – MADERA (DISTRICT 1) LEAD PLANNER: BECKY BEAVERS

Bob Shockley is requesting a Conditional Use Permit (CUP #2017-028) to allow a gas station/mini mart. The property is owned by Vernon Wayne Stoeckel and is located on the north side of Avenue 12 at its intersection with Kensington Drive (no address available), Madera. The property is zoned CRM/MHA (Commercial, Rural, Median/Manufactured Housing Architectural Review Overlayed) District. Eduardo T. Castaneda Contreras is requesting a Conditional Use Permit (CUP #2017-024) to allow an auto service and tire retail store. The property is owned by Edward E. Campbell Tr. and is located on the east side of Road 26, approximately 540 feet north of its intersection with Ellis Street (16456 Road 26), Madera. The property is zoned CRM (Commercial, Rural, Median) District. A draft Mitigated Negative Declaration (MND #2017-36) has been prepared concerning the proposed project in compliance with provisions of the California Environmental Quality Act (CEQA). ### 4. GARLAND RUSSELL SHAW – GENERAL PLAN (GP #2017-002) – MADERA (DISTRICT 1) LEAD PLANNER JAMIE BAX

Garland Russell Shaw and the Golden Valley Unified School District have requested a General Plan Text Change to amend the Road Classification of Avenue 12 from Road 35 to Road 36 from Limited Expressway to Arterial. #### PLANNING COMMISSION MEETING PROCEDURES

Planning Commission meetings are conducted under the direction of the Chairman. Each item scheduled for public hearing at a Planning Commission meeting will be announced by the Chairman, and the hearing will be conducted as follows:

- The Planning staff will present their report and recommendation on the matter being heard. Commission members will be provided an opportunity to question staff.
- 2. The Chairman will first ask the project applicant or proponent to present any points they feel the Commission should understand about their proposal. The Commission may ask questions.
- 3. The Chairman will ask those in support and then those opposed to the application to come to the podium and present any testimony they wish to give in regard to the proposal being considered.
- 4. The Chairman will offer the project applicant an opportunity for rebuttal of any testimony against the proposal or to clarify information previously presented.
- 5. The public comment portion of the hearing will be closed and the matter will be deliberated by the Commission and a decision will be rendered.
- 6. Persons wishing to appeal a decision must present a written notice of appeal together with the fee to the planning commission secretary whose office is located at the Madera County Government Center 200 West 4th Street, 3rd floor, Madera CA. The notice and fee must be received within 15 days of the date the decision is rendered

#### **RULES FOR PRESENTING TESTIMONY**

All persons who wish to present testimony to the Planning Commission in a public hearing must observe the following rules:

- 1. All testimony must be presented from the podium. When beginning to speak, first identify yourself, County of residence, and interest in the matter. This is required for the public record. Since all meetings are recorded, please speak clearly and use the microphone provided.
- 2. All remarks must be addressed to the Chair. Conversation or debate between a speaker at the podium and a member of the audience or staff is not permitted.
- 3. Please keep your remarks as brief as possible. Focus your testimony on the most important facts you wish to be considered. Avoid duplicating testimony provided by others.
- 4. Planning Commission hearings can involve highly emotional issues, so it is important that all participants conduct themselves with courtesy, dignity, and respect.
- 5. Whenever possible, written testimony should be presented as well as oral. Written testimony should be submitted for Planning Commission consideration in advance of the actual hearing date.
