#### D. PUBLIC COMMENT PERIOD

Lynda Kaufmann, Director of Government & Public Affairs of Psynergy Programs Inc. Psynergy is a contracted provider with Behavioral Health Services. The program is to provide and customize treatment plans for individuals to graduate from locked settings into successful community living. A representative will be attending Behavioral Health Board meetings to see what community needs are.

# E. EDUCATIONAL PRESENTATION

Emerson Carrick, Emerson House Manager, Madera Rescue Mission – The Emerson House was established by the Mentally III Offender Crime Reduction grant in late 2015. The grant consisted of Probation and Behavioral Health Services (BHS) working together the grant ended in June of 2018 and Behavioral Health Services continued the program. The Emerson House (named after Emerson Carrick) has 10 beds available; 8 of the beds are for men and 2 are for women. There are two levels to the building upstairs are 4 rooms that have 2 beds each and down stairs are 2 room designated for women. The program provides food, clothing and medication management. Files and notes are kept on each of the clients, each of the clients are assigned jobs to perform. There have been 44 men and 11 women that have been

served at the Emerson House since 2015. It is a sober living program. There is staff available 24 hours a day 7 days a week. There are security cameras in the common areas. All referrals come from BHS, the clients are usually needing a change from a toxic home environment, are homeless, or have just been release from jail. October 4, 2019 is the Madera Rescue Mission Fundraising Banquet, Supervisor Poythress encouraged all in attend to be involved financially as the Mission provides valuable service to the community of Madera. Dennis expressed his appreciation to Emerson on the way he continually goes above and beyond the call of duty.

Juliette Hamilton, Administrative Analyst, shared the Performance Outcome Quality Improvement (POQI) Report – Spring 2019. There is a State requirement that twice a year a Performance report is offered. This year a bi-lingual staff was part of handing out the surveys which did show an increase in the Hispanic population participation. The outcomes were discussed and a few of the comments were read, both positive and negative.

# 2. <u>BEHAVIORAL HEALTH SERVICES (BHS) PROGRAM REPORTS</u>

Maria Torres, BHS Program Supervisor, Substance Use Disorder Services (SUD). BHS has three sites that offer SUD services; Oakhurst Counseling Center, Chowchilla Recovery Center, BHS 7<sup>th</sup> Street. The SUD program offer outpatient prevention and treatment programs for adults and juveniles with substance abuse problems. The services include individual, family and group counseling.

#### H. DIRECTOR'S CORNER - Dennis P. Koch, Director, Behavioral Health Services

Dennis reported on the following:

- The 2019/20 Budget was approved The will be an increase in staffing but recruitment is at a difficult place due to the fact that there are Mental Health dollars available and all areas of the field are hiring.
- Both housing project were funded
  - Madera Village the project behind Carl's Jr. will have 56-60 units and 14 of them will be designated for mental health clients. 24 million dollar project 4 million will be mental health funds.
  - Downtown Madera Veterans and Family Housing on the corner of C Street and 5<sup>th</sup> Street. One corner will consist of 24 Single housing units of which 7 will be designated for mental health. Veterans will have priority. 24 million dollar project a half a million dollar will be mental health funds.
- Community Action Partnership Madera County (CAPMC) have provided 2 homeless outreach staff who are doing an outstanding job.
- 5150 are down over the last 6 months almost in half.
- Program working with mom's, either right after birth or still pregnant, on the dangers of marijuana and nursing babies.
- Data Notebook 2019 it has been suggested that BHS have a committee with members from to complete the Data Notebook. Dawn, Glenna and Eric have volunteered.
