Lori shared that she and Angela stay in contact with clients when they are in programs to help them have tools to be successful for when they are no longer in program. The referrals that are received are from Madera Police Department, Madera Sherriff's Department, Hope House and other agencies. Angela shared how Madera Community Hospital helped one of their senior clients have a bed, shower and care during their last days. Angela also shared about the Point in Time Count and emphasis the importance of having a correct count. 831 1033). Dale Hudak from Hope House thanked both of the outreach workers and expressed what a good job they are doing and what a large difference they are making.

H. DIRECTOR'S CORNER – Dennis P. Koch, Director, Behavioral Health Services

A handout was distributed regarding the California Behavioral Health Directors Association (CBHDA) Report. Within the report is the CalAIM Waiver report. Dennis will be sharing for the next few Board Meetings the high points of the plan. Today he shared the Priority Populations and Statewide Goals. Counties would initially focus on four priority populations in effort to transform and improve outcomes. The four populations are: 1. Long-term outcomes for individuals living with Severe Mental Health Illnesses and Substance use disorders. Goal 1 is to reduce early preventable death, Goal 2 is to improve access to and quality of crisis services, Goal 3 is to reduce incidences of suicides and self-harm.

2. Individuals with SMI or SUDs at-risk of or currently experiencing homelessness. Goal 4 is to end Homelessness for Individuals living with SMI or SUD Conditions in California. 3. Children and transition aged youth who are at risk of or have a serious emotional disturbance (SED) focusing on youth in child welfare and the juvenile justice systems. Goal 5 Promote prevention-orientated early identification and treatment for all children living with trauma. Goal 6 Improve quality, duration and availability of behavioral health services to foster youth. 4 Justice-involved populations with SMI or SUD from diversion through to reentry. Goal 7 Reduce criminal justice detentions. Goal 8, increase employment. Dennis will be presenting Highlights of Specific goals in January and Build Blocks for Transformation in February.
