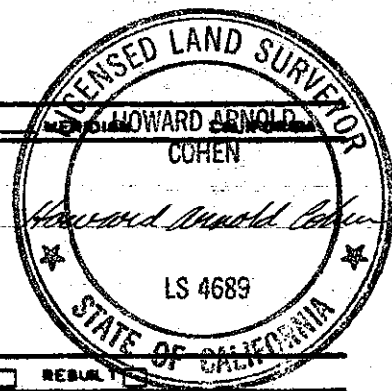

 SET: Standard F.S.M., up 7". Set a fiberglass post 4'± NE of the monument with a Forest Service Monument sign attached.  
 F.S.M.: Aluminum monument, 2½" O.D., 30" long with a 3¼ O.D. aluminum cap; stamped for the corner, with LS 4689, the date and the Forest Service logo.

- A Red Fir, 13.0" dia., bears N 41° 36' W, 18.20'.
- A Draw (which bears N 10° W), bears East, 35'±.
