Re: Response of the Sherman Thomas Charter Schools to the 2013-14 Grand Jury Report.

Honorable Judge Ernie LiCalsi,

In accordance with Penal Code section 933.05, the Sherman Thomas Charter Schools submits this response to the Madera County Grand Jury pertaining to their examination of our schools.

The following is the response to the Grand Jury Report. (A copy of the Grand Jury Report with the numbered Findings and Recommendation is enclosed for reference.)

## Response to the Findings

Finding 1. The respondent agrees with this finding in part and disagrees in part. The Board of Directors agree that the majority of the expenditures are purchased by the credit cards to expedite the process and are sometimes the only way that companies receive payment. The credit card was used to purchase items for the Christmas Party, however when the invoice was paid the items relating to the Christmas Party were paid from private donations, not with public funds.

Finding 2. The respondent agrees with this finding in part and disagrees in part. The Board of Directors agrees that the expenditures are processed and categorized by the office manager, but this is only one part of the procedure.

Sherman Thomas Charter School in its conception has had oversight by the Madera Unified School District in all school operations including financial matters, but also goes through several other checks and balances including the following;



1. School administration approval, 2. Charter school board approval, 3. Fiscal accounting oversight of Madera County Office of Education, 4. Charter school financial analyst, 5. Independent state approved auditor's audit, and finally 6. California State Controller's audit each year.
