PUBLIC HEARINGS:

- *1. RNG MOOVERS, LLC – CONDITIONAL USE PERMIT (CUP #2020-009) - CHOWCHILLA (DISTRICT 2) LEAD PLANNER: ROBERT MANSFIELD**

RNG Moovers, LLC is requesting a Conditional Use Permit (CUP #2020-009) to amend Conditional Use Permit #2005-037 to allow construction of a dairy digester and biogas injection facility into PG&E infrastructure via scrubbing at source and transferring through private pipeline gathering system. The property is owned by Soares Dairy and is located on the east side of Road 1, approximately one mile south of its intersection with Avenue 21 (no situs) Chowchilla. The property is zoned ARE-40 (Agricultural, Rural, Exclusive – 40 Acre). A draft Mitigated Negative Declaration (MND #2020-12) has been prepared concerning the proposed project in compliance with provisions of the California Environmental Quality Act (CEQA) and is available together with the Initial Study for public review at the Madera County Planning Department. Size: 479.93. APN: 020-170-011.

- *2. RNG MOOVERS, LLC – CONDITIONAL USE PERMIT (CUP #2020-010) - CHOWHILLA (DISTRICT 2) LEAD PLANNER: ROBERT MANSFIELD**

RNG Moovers, LLC is requesting a Conditional Use Permit (CUP #2020-010) to amend Conditional Use Permit #2005-030 to allow construction of a dairy digester biogas facility and to truck resultant biogas to an injector site and an existing dairy. The property is owned by Costa View Dairy and is located on the southeast corner of Avenue 17 and Road 12 (no situs) Chowchilla. The property is zoned ARE-40 (Agricultural, Rural, Exclusive – 40 Acre). A draft Mitigated Negative Declaration (MND #2020-13) has been prepared concerning the proposed project in compliance with provisions of the California Environmental Quality Act (CEQA) and is available together with the Initial Study for public review at the Madera County Planning Department. Size: 632.74. APN: 023-210-001.

- *3. NFV-1 INVESTMENTS, LLC – TENTATIVE SUBDIVISION MAP (S #2020-001) MADERA (DISTRICT 1) LEAD PLANNER: KAMARA BIAWOGI**

A request by NFV-1 Investments, LLC for a Tentative Subdivision Map (S #2020-001) on 78.50 acres. This would consist of 156 lots. The property is owned by NFV-1 Investments, LLC, and is located on the north side of Road 206, approximately 1.06 miles southeast of its intersection with Road 145 (no situs), Friant. The present zones are NFV-MDR (North Fork Village – Median Density Residential), NFV-MU (North Fork Village – Mixed Use) and NFV-OS (North Fork Village – Open Space). Size: 78.50 acres. - *4. WILSON PREMIER HOMES – TENTATIVE SUBDIVISION MAP (S #2020-002) MADERA (DISTRICT 1) LEAD PLANNER: JAMIE BAX**

A request by Wilson Premier Homes for a Tentative Subdivision Map (S #2020-002) on 13.47 acres. This would consist of 169 lots and 18 outlots. The property is owned by Groveland Development Corporation and is located on the southwest corner of Avenue 12 and Riverstone Boulevard (no situs), Madera. The present zones are GV-R (Gateway Village – Residential). Size: 13.47 acres. APN's: 080-170-004.

PLANNING COMMISSION MEETING PROCEDURES

Planning Commission meetings are conducted under the direction of the Chairman. Each item scheduled for public hearing at a Planning Commission meeting will be announced by the Chairman, and the hearing will be conducted as follows:

1. The Planning staff will present their report and recommendation on the matter being heard. Commission members will be provided an opportunity to question staff.
2. The Chairman will first ask the project applicant or proponent to present any points they feel the Commission should understand about their proposal. The Commission may ask questions.
3. The Chairman will ask those in support and then those opposed to the application to come to the podium and present any testimony they wish to give in regard to the proposal being considered.
4. The Chairman will offer the project applicant an opportunity for rebuttal of any testimony against the proposal or to clarify information previously presented.
5. The public comment portion of the hearing will be closed and the matter will be deliberated by the Commission and a decision will be rendered.
6. Persons wishing to appeal a decision must present a written notice of appeal together with the fee to the planning commission secretary whose office is located at the Madera County Government Center 200 West 4th Street, 3rd floor, Madera CA. The notice and fee must be received within 15 days of the date the decision is rendered

RULES FOR PRESENTING TESTIMONY

All persons who wish to present testimony to the Planning Commission in a public hearing must observe the following rules:

1. All testimony must be presented from the podium. When beginning to speak, first identify yourself, County of residence, and interest in the matter. This is required for the public record. Since all meetings are recorded, please speak clearly and use the microphone provided.
2. All remarks must be addressed to the Chair. Conversation or debate between a speaker at the podium and a member of the audience or staff is not permitted.
3. Please keep your remarks as brief as possible. Focus your testimony on the most important facts you wish to be considered. Avoid duplicating testimony provided by others.

4. Planning Commission hearings can involve highly emotional issues, so it is important that all participants conduct themselves with courtesy, dignity, and respect.
5. Whenever possible, written testimony should be presented as well as oral. Written testimony should be submitted for Planning Commission consideration in advance of the actual hearing date.
