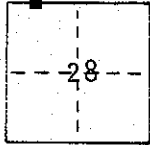

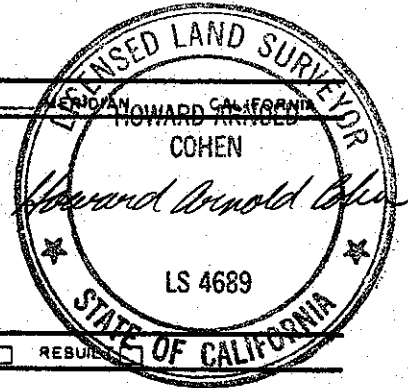

PHYSICAL DESCRIPTION OF MONUMENTS REBUILT OR PERPETUATED

SET: Standard FSM, up 6". Set a fiberglass post 4' ± SW of the monument with a Forest Service "Monument" sign attached.
FSM - Aluminum monument, 2 1/2" O.D., 30" long with a 3 1/4" O.D. aluminum cap; stamped for the corner, with L. S. 4689, the date, and a Forest Service logo.

CORNER TIES:

- A fence (which bears West), bears North 2.8'.
- A ponderosa pine, 8.5" dia., bears S 20° 15' E, 17.15'.
- A ponderosa pine, 10.0" dia., bears S 76° 25' W, 33.69'.
- . Bearings are to the center of trees at the base. Distances are horizontal to a nail and tag (stamped L. S. 4689) driven into the side-center of the root crown.
- . Posted Forest Service monument and bearing tree signs.
- . Blazed bearing trees.
- . Stamped monument in accordance with the BLM 1973 "Manual of Surveying Instructions."
