#### E. EDUCATIONAL PRESENTATION

Marizela Terkildsen, Health Education Coordinator, Suicide Prevention Collaborative. The Madera County Suicide Prevention Collaborative has a new name it is Madera Together for Suicide Prevention. The coalition was started because of an obvious rise in numbers FY 17-18 and increase of 50% from 10 in FY 16 -17 to 21 in FY 17-18. The collaborative got together in 2018 and had general meetings in 2019 they became more solidified and now in 2020 the collaborative has grown. Some of the participants are Behavioral Health, Public Health, Educational agencies like MUSD one of the founders Bass Lake, Chawanakee, GVUSD, Chowchilla Unified. Law Enforcement agencies, health care/insurance providers, Valley Children's Hospital, NAMI National Alliance on Mental Illness, California Health Collaborative and the Madera Ministerial Association. The Mission Statement is to support prevention, intervention and postvention with the goal of reducing suicide and promoting community wellness. Community wellness is finding support for the person and the family. The purpose

of the collaborative is to align local suicide prevention resources, raise local awareness of suicide prevention activities, to educate the community about the importance of suicide prevention awareness. 2020 presented some unique opportunities in outreach. Some of the activities were: Drive through self-care/wellness event, virtual Mental Health First Aid trainings, virtual "know the signs" campaign, suicide awareness kit distribution, a collaborative logo art contest, Suicide 101 classes, virtual wellness and maternal wellness. Pictures were shared on the different events including sidewalk chalk art done by Kingsview youth. A video created by Camarena Health was suggested on you tube called Camarena Health Stigma. Question and answer period.

## 3. <u>BEHAVIORAL HEALTH SERVICES (BHS) PROGRAM REPORTS</u>

Irene Blanco, LCSW Supervising Mental Health Clinician Irene has 15 years of experience with BHS and 2 years of experience as a Supervisor. reported she supervises two teams. One is with clients who are in the Juvenile Justice System, either on formal or informal probation. There are 3 clinicians, 1 case manager. There is one therapist that is housed at the Juvenile Hall 40 hours a week and services are offered to all they do not have to be a client. Most all services are being held by zoom or on the telephone. There are case by case in person meetings. There is also a court mandate group named Pathways that is taking place the group is for 1 year for sex offenders.

The second team are the children that are a part of the child welfare system. There are 5 clinicians and 3 case managers. Child Welfare refer to BHS and if they meet criteria, services are provided. The services are for the biological family and the foster family to provide support and education. The higher acuity clients participate in Intensive Home Base Services (IHBS). IHBS is contracted with JDT and services are in the home one on one, in addition to BHS support. The average case load at the current time is 40, which is high, however there are a couple staff out on maternity leave and a couple of new staff being hired. There is not a waiting list, and no one is turned down. The hope is that more services can be provided with maybe a combination of telehealth and in office meetings.

## H. <u>DIRECTOR'S CORNER – Dennis P. Koch, Director, Behavioral Health Services</u>

Dennis reported on AB1776 also know as Laura's Law. A copy of the document will be emailed to all BHB members after the meeting. The sections that are highlighted in red are changes (usually just wording) and the blue highlights are the additions. Section 1-9 is regarding eligibility. Sections A-F are how requests can be made. Behavioral Health Services Directors conducts the investigation and confirm appropriateness and then file a petition. The person rights are listed in section 4 A-I. The court shall or not order adult outpatient treatment, if the person refuses, may be subject to 5150 hold. If they meet the criteria. Section 5348 Services offered: (1) mobile multidisciplinary Mental Health team (2) Outpatient service planning and delivery process as stated in A-H. (3) services coordinator (4) individual services plan A-J. Involuntary medication shall not be allowed. Data recording and reporting 1-14. Section 5349 includes no voluntary services are reduced due to adult outpatient treatment implementation. To opt out a resolution by the Board of Supervisors stating reasons to opt out and facts relied on to make that decision. The issue is the workload on the courts. Sometimes when a Judge is who orders treatment it is more successful. After the first of the year information is coming from other counties who have opted in and they will share their experience.
