PUBLIC NOTICE OF AVAILABILITY OF A DRAFT ENVIRONMENTAL

IMPACT REPORT/ FOR THE GATEWAY VILLAGE AREA PLAN

Madera County, as lead agency, has prepared a Draft Environmental Impact Report (EIR) for the Gateway Village Area Plan. The Gateway Village Area Plan proposes a development of a comprehensive planned conversion of 2,062 – acres site to urban uses. The master planned community as proposed would consist of 1,457 acres of 5,836 low-density residential units, 132 acres of commercial and mixed use (including 742 residential units), 40 acres of highway service commercial uses, 19 acres of neighborhood commercial uses, 148 acres of open space, and 177 acres of right-of-way. The project site also includes existing light industrial uses (89 acres). In addition, the project includes improvements to some off-site area (approximately 2,940 acres) related to infrastructure improvements.


The EIR evaluates potential environmental impacts relating to Aesthetics, Biological Resources, Land Use / Planning, Mineral Resources, Public Services, Utilities / Service Systems, Agriculture Resources, Cultural Resources, Hydrology / Water Quality, Noise, Recreation, Air Quality, Geology /Soils, Hazards & Hazardous Materials, Transportation/Traffic and Population / Housing.
