There were no comments from the public.

CONSENT AGENDA

4. Minutes – Review and Approval of the January 23, 2019 Meeting

Commissioner Wheeler moved to approve the January 23, 2019, Minutes as presented and Commissioner Rodriguez seconded the motion. The motion was approved with a 5-0 vote.

PUBLIC HEARING

5. <u>Delegation of Principal County Authority to Merced LAFCo – Chowchilla Water District</u> (Continued from January 23, 2019 Agenda)

Executive Officer Braun presented staff's report and recommendation to approve Merced LAFCo's request for authority to process the application.

Commissioner Medellin asked if there was any kind of outreach to the landowners to see if there was any opposition. Braun said that it was his understanding that the landowners were involved in applying to Merced LAFCo to annex their property. Commissioner Medellin asked if Madera County would lose anything else other than the authority to process the annexation. Braun said that if Madera LAFCo denied Merced's request, the landowners would be required to apply to Madera LAFCo first to get the area removed from the Chowchilla Water District's SOI and then go to Merced LAFCo to expand Le Grand-Athlone's SOI to include their property. Braun said that any other landowner in Merced County within the Chowchilla Water District's SOI wishing to annex their land to the Le Grand-Athlone Water District would still have to apply to Madera LAFCo to delegate authority to Merced County because Madera is the Principal County.

There being no further comments, Commissioner Wheeler made a motion to approve Merced LAFCo's request for jurisdiction to process the annexation to the Le Grand-Athlone Water District and Commissioner Medellin seconded the motion. The motion passed on a vote of 5-0.

6. <u>Selection of Consultant for Preparation of Municipal Service Review – Bass</u> Lake/North Fork Area Districts

Braun presented staff's report and recommendation. There were no further comments and Commissioner Wheeler made a motion to approve the proposed contract with QK to prepare the MSR and to authorize the Executive Officer to sign all necessary documents. Commissioner Medellin seconded the motion and the motion passed on a vote of 5-0.

- 7. Proposed 2019/2020 Fiscal Year Budget
 - A. Employee Salary Increase Executive Officer and Clerk
 - B. 2019/2020 Budget/Schedule of Fees and Charges

Commissioner Medellin asked if Item B could be discussed prior to the discussion of Item A. The Commission agreed and Item B was discussed first.

B. <u>Proposed Budget/Fee Schedule</u>

Braun presented staff's report. Braun noted that the 2019/20 Budget was almost the same as the 2018/209 budget; however, he added \$456 to memberships since the CALAFCO membership increased. Braun said he also increased the category for

outside consultants by \$9,991 to cover the Bass Lake/North Fork MSR and an additional MSR. Staff plans to encumber \$19,991 from this account and place it in next year's budget to pay for these MSRs.

Braun said he didn't change the budget for salaries for the EO and clerk because it looks like the line item for salaries will be about \$6,500 below what was allocated for this fiscal year and would accommodate an 8% salary increase without increasing the budget.

Braun said the Commission is funding part of the 2019/2020 budget with the operating fund balance which at the beginning of the 2018/2019 fiscal year was about \$85,000. Braun said the fund balance at the beginning of the 2019/2020 fiscal year will be about \$65,000. Since the fund balance is being reduced, the Commission will require a little more from the cities (Madera – approximately \$6,300; Chowchilla – approximately \$700; and County approximately \$7,000) to fund the budget.

Commissioner Medellin asked if the amount was based on population. Braun said that according to the LAFCo law, the County is to pay 50% and the other 50% is to be based on each city's total budget as provided by the State Controller. Braun said the City of Madera will be paying approximately 40% while the City of Chowchilla will be paying approximately 10%.

Commissioner Medellin asked if there is a policy for how much the Commission should keep in its reserve account. Braun responded that the policy only states the reserve account could not exceed one year's total budget.

Commissioner Wheeler made a motion to approve the proposed budget as presented and Commissioner Medellin seconded the motion. The motion passed by a vote of 5-0.

C. Employee Salary Increase

Commissioner Wheeler said he totally agreed with the employee salary increase but thought the Commission might want to discuss also increasing their stipend. Commissioner Medellin suggested increasing their stipend from \$100 to \$125. Commissioner Medellin said that there was justification for the salary increase but didn't want to tie the increase to the County's salary since LAFCo is not part of the County. Commissioner Wheeler agreed and said the language should be changed on the justification to just say 8% once the employees reached 1,000 hours. Commissioner Wheeler asked if the Commission could consider raising their stipend at the next meet by 8% or to \$125 per meeting. Commissioner Wheeler also noted that the Chairman of the Board of Supervisors made \$500 more per month and that the Commission might want to consider giving the Chairman of the Commission an additional \$25 per month. The Commission directed staff to place an item on the next agenda regarding an increase in the Commission's stipend.

Commissioner Medellin made a motion to approve the merit increase for the two Commission employees by 8% after working 1,000 hours. Commissioner Wheeler seconded the motion and the motion was approved on a 5-0 vote.

8. Consideration of Appointment for Public Member At-Large

Braun said the Commission's Member At-Large's term is due to expire in May and that the Commission needed to take an action to either grant Commissioner Graham another term or direct staff to begin recruiting for another Member At-Large. Commissioner Medellin said that Commissioner Graham was doing an excellent job and is willing to continue serving on the Commission. Commissioner Rodriguez moved to grant Commissioner Graham another term of four years and Commissioner Wheeler seconded the motion. The motion passed by a vote of 5-0.

9. <u>Commissioners Reports</u>

Commissioner Wheeler said he received a report that there was a tornado coming to the mountain area.

Commissioner Medellin thanked the Commission for their service and said he felt the County and the Cities worked well together to get a lot accomplished.

10. <u>Executive Officer Reports</u>

Braun reminded the Commissioners that their Statements of Economic Interest were due on the 1st of April.

11. Adjournment

The meeting adjourned at 6:36 p.m.

SUBJECT:

City of Madera – Ellis-D Street Annexation (2018-005)

I. PROPOSAL

This application proposes the annexation of seven parcels consisting of approximately 20 acres to the City of Madera. The annexation is located on the west side of North "D" Street between Ellis and Adell Streets.

Shizao Zheng submitted an application for annexation to the City of Madera of the two northerly parcels along Ellis Street. The applicant is proposing to develop these two parcels with a 61-lot single-family residential subdivision. LAFCO, in an effort to provide a more uniform boundary, expanded the application to include five additional parcels extending south along North "D" and Adell Streets. These parcels are developed with single-family residences and a church.

II. BACKGROUND

Contiguity

The area proposed for annexation is contiguous to the City of Madera. As noted above, LAFCo added five parcels to the annexation in order to provide a more uniform boundary.

Infrastructure

The area would receive water and sewer services from the City of Madera which currently has existing infrastructure adjacent to the property. It is noted that the property owners of the five parcels that were added to the annexation have entered into out-of-area service agreements with the City of Madera in order to connect to City of Madera sewer and/or water services.

Environmental Review

The City of Madera issued a Negative Declaration for the project dated December 20, 2018, which is considered adequate for the proposed annexation.

III. ANALYSIS

The purpose of the proposed annexation is to allow for the development of the northerly two parcels with a single-family residential subdivision utilizing City services. The other parcels are being included to provide a more uniform City/County boundary. Some of these parcels may currently receive City of Madera water and/or sewer services through out-of-area service agreements. It is appropriate to centralize the governance of all the urban services and land use control for this area under the City, as the City is the most efficient provider of these services.

Pursuant to Section 99 of the California Revenue and Taxation Code, the City and County have entered into an agreement for property tax exchange.

Government Code Section 65580, et al. requires that the redistribution of regional housing needs allocation (RHNA) must be discussed and agreed upon as part of the housing element process or by agreement. The RHNA numbers listed below for this project are based on the formula agreed to by the City of Madera and the County of Madera in collaboration with HCD.

The City of Madera approved the prezoning of the property on March 20, 2019, as required by Section 56375 of the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000.

Pursuant to Government Code Section 56668, staff has reviewed the specific factors and has prepared an analysis of those points (See Exhibit F). Other than issues previously addressed in this report, no issues of significance were identified for the annexation of this area.

IV. <u>RECOMMENDATION</u>

Staff recommends that the Commission approve the proposed annexation, subject to the following conditions and findings:

V. CONDITIONS AND FINDING

- The annexation shall consist of seven parcels on approximately 20 acres as shown on Exhibit "A". The annexation shall also include the street right-of-way of North "D" Street, Ellis Street, Sonora Street and Adell Street adjacent to the subject properties.
- 2. The applicant shall cause to be prepared, to the satisfaction of the Madera LAFCo Executive Officer, such documents and legal descriptions as are deemed necessary for filing a statement of boundary change with the State Board of Equalization. Any necessary fees or costs for processing and documentation shall be paid by the applicant.
- 3. Pursuant to Section 99 of the California Revenue and Taxation Code, the City and County have entered into an agreement for property tax exchange and redistribution of regional housing needs allocation "RHNA". The "RHNA" numbers listed below are in agreement with the formula agreed to by the City and the County.

4. The short-term designation shall be "City of Madera – Ellis-"D" Street Annexation (2018-005).

- 5. Comply with the attached memorandum from the California Department of Transportation dated December 28, 2018.
- 6. The annexation is uninhabited as defined by Government Code Section 56046.
- 7. The City of Madera's Mitigated Negative Declaration has been reviewed, found to be in compliance with CEQA, and considered adequate for the annexation; the adoption of this document is, therefore, justified.
- 8. It is the intent of the Commission to waive subsequent protest hearings and election proceedings pursuant to Government Code Section 56663.
- 9. Direct the Executive Officer to prepare and execute a Certificate of Completion upon receipt of required processing fees required by Section 57200 (made payable to the State Board of Equalization).







ORDINANCE NO. 961 C.S

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF MADERA AMENDING THE OFFICIAL CITY OF MADERA ZONING MAP TO PREZONE APPROXIMATELY 20 ACRES OF PROPERTY LOCATED SOUTH AND WEST OF THE INTERSECTION OF ELLIS STREET AND NORTH D STREET INTO THE PD-6000 (PLANNED DEVELOPMENT) ZONE DISTRICT.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MADERA AS FOLLOWS:

SECTION 1. The Planning Commission of the City of Madera and this Council have held public hearings upon the prezoning of these properties and have determined that the proposed prezoning is consistent with the General Plan as amended and subsequent development will be in conformance with all standards and regulations of the Municipal Code.

SECTION 2. The City of Madera Zoning Map as provided for in Chapter 3 of Title X of the Madera Municipal Code is hereby amended as illustrated in the hereto attached Exhibit "A" which indicates the segment of the City of Madera Zoning Map to be amended. Unless the adoption of this amendment to the Zoning Map is lawfully stayed, thirty-one (31) days after adoption of this amendment, the Planning Manager and City Clerk shall cause these revisions to be made to the City of Madera Zoning Map which shall also indicate the date of adoption of this revision and be signed by the Planning Director and City Clerk.

SECTION 3. Based upon the testimony and information presented at the hearing, the adoption of the proposed prezoning is in the best interest of the City of Madera, and the Council hereby approves the prezoning based on the following findings:

FINDINGS:

- 1. THE PROPOSED PREZONE WILL PROVIDE THE REQUIRED CONSISTENCY BETWEEN THE GENERAL PLAN AND ZONING.
- 2. THE PREZONE IS NOT EXPECTED TO BE DETRIMENTAL TO THE HEALTH, SAFETY, PEACE, COMFORT OR GENERAL WELFARE OF THE NEIGHBORHOOD OR THE CITY.
- 3. CITY SERVICES AND UTILITIES ARE AVAILABLE OR CAN BE EXTENDED TO SERVE THE AREA.

SECTION 4. This Ordinance shall be effective and of full force and effect at 12:01 a.m. on the thirty-first day after its passage.



Dear Mr. Braun:

Thank you for the opportunity to review the proposed annexation of the approximately 20 acre property on the west side of D Street between Adell and Ellis Streets to the City of Madera (project). The project includes a tentative tract map of a 61-unit single family residential subdivision. Caltrans provides the following comments consistent with the State's goal of supporting vibrant economy and sustainable communities:

Caltrans supports the City of Madera's effort to add inventory to California's strained housing market. The project location is adjacent to existing residential land uses and can reasonably be expected to integrate with Madera transit services. Additionally, the Madera County Transportation Commission has identified several capacity-enhancing projects near the proposed annexation (at Cleveland Avenue, D Street, and Golden State Boulevard), which should aid in vehicular traffic circulation as the area grows. When evaluating development of this project site Caltrans encourages the City to consider non-vehicular modes of transportation. Smart growth principles, outlined in the San Joaquin Valley Blueprint Planning Process, such as providing a range of housing and transportation choices, creating walkable neighborhoods, preserving open space, and mixed land uses may be applicable to this location—adding to the city's vitality and sustainability.

Listed below is an outline analysis of the minimum factors that are required to be considered by LAFCO in a reorganization. The analysis of these factors below pertains to the City of Madera – Ellis and "D" Street Annexation (2018-005). Factors that indicate "Some Concern" or "Significant Issue" are discussed at this end of this analysis or are referenced to sections of the corresponding Executive Officer's Report.

56668. Factors to be considered in the review of a proposal shall include, but not be limited all of the following:

(a) Population and population density;

land area and land use:

per capita assessed valuation;

topography, natural boundaries, and drainage basins;

proximity to other populated areas;

the likelihood of significant growth in the area, and in adjacent incorporated and unincorporated areas, during the next 10 years.

(b) Need for organized community services;

the present cost and adequacy of governmental services and controls in the area:

probable future needs for those services and controls:

probable effect of the proposed incorporation, formation, annexation, or exclusion and of alternative courses of action on the cost and adequacy of services and controls in the area and adjacent areas. "Services," as used in this subdivision, refers to governmental services whether or not the services are services which would be provided by local agencies subject to this division, and includes the public facilities necessary to provide those services.

- (c) The effect of the proposed action and of alternative actions, on adjacent areas, on mutual social and economic interests, and on the local governmental structure of the county.
- (d) The conformity of both the proposal and its anticipated effects with both the adopted commission policies on providing planned, orderly, efficient patterns of urban development, and the policies and priorities set forth in Section 56377.
- (e) The effect of the proposal on maintaining the physical and economic integrity of agricultural lands, as defined by Section 56016.

- (f) The definiteness and certainty of the boundaries of the territory, the nonconformance of proposed boundaries with lines of assessment or ownership, the creation of islands or corridors of unincorporated territory, and other similar matters affecting the proposed boundaries.
- (g) Consistency with city or county general and specific plans.
- (h) The sphere of influence of any local agency which may be applicable to the proposal being reviewed.
- (i) The comments of any affected local agency.
- (j) The ability of the newly formed or receiving entity to provide the services which are the subject of the application to the area, including the sufficiency of revenues for those services following the proposed boundary change.
- (k) Timely availability of water supplies adequate for projected needs as specified in Section 65352.5.
- (I) The extent to which the proposal will affect a city or cities and the county in achieving their respective fair shares of the regional housing needs as determined by the appropriate council of governments consistent with Article 10.6 (commencing with Section 65580) of Chapter 3 of Division 1 of Title 7.
- (m) Any information or comments from the landowner or owners.
- (n) Any information relating to existing land use designations.
- (o) The extent to which the proposal will promote environmental justice. As used in this subdivision, "environmental justice" means the fair treatment of people of all races, cultures, and incomes with respect to the location of public facilities and the provision of public services.

PROPOSAL

It is recommended that the Commission approve the final budget and fee schedule for fiscal year 2019-2020 (Exhibit A).

BACKGROUND

Pursuant to Government Code Section 56381, the Commission must adopt a proposed budget by May 1, 2019, and a final budget by June 15, 2019, after consideration at a noticed public hearing. The statute further requires that the budget must at least be equal to the budget adopted for the previous fiscal year, unless the Commission finds "that reduced staffing or program costs will nevertheless allow the Commission to fulfill its purposes and programs." After a careful review of our agency's budget, staff has proposed a budget that is a slight increase from the previous year. Staff believes it is consistent with workload estimates anticipated for the upcoming fiscal year.

The 2019-2020 Fiscal Year Budget proposes one small increase to the previous year's budget (\$456) to cover the cost of the CALAFCO Membership. The budget also includes an encumbrance of \$19,991 for the Bass Lake/North Fork MSR in the category of outside consultants. The 2018-2019 Fiscal Year Budget included funds for the Bass Lake/North Fork MSR, however, the MSR will not be completed until the 2019-2020 Fiscal Year. Staff anticipates the completion of the Bass Lake/North Fork MSR and one other MSR within the 2019-2020 Fiscal Year. The cost of the Bass Lake/North Fork MSR came in at the anticipated \$35,000 (\$19,991 of which has been encumbered). The budget contains an additional \$25,000 for a second MSR which is anticipated to be less costly than the Bass Lake/North Fork MSR.

It is noted that the Budget for Salaries and Employee Benefits is not proposed to change, despite the increase in salaries for the Executive Officer and Clerk and the increase to the Commissioners' stipend for attendance at Commission meetings. The anticipated expenditure for salaries and benefits for the 2018-2019 fiscal year is \$6,463 below budget and therefore the existing budget could accommodate the salary and stipend increases.

The 2019-2020 Fiscal Year budget would include the \$65,981.75 in the Operating Fund; however, it would not propose to include any of the funds in the Reserve Fund. The current balance in the Reserve Fund is an appropriate amount for any unexpected expenses (litigation, studies, etc.). It is noted that the anticipated balance in the Operating Fund at the beginning of the 2019-2020 Fiscal year (\$65,981.75) represents a decrease from the anticipated balance in the fund at the beginning of the

2018-2019 Fiscal Year (\$69,503.96). Since the 2019-2020 Fiscal Year Budget proposes an overall increase of \$10,447 (including encumbrance) and the amount in the Operating Fund has been decreased, the contributions from the County and Cities has been increased from last year.

In previous years, the Commission has annually made small increases to the fee schedule in order to keep pace with inflation. This past year the consumer price index was 1.6% through January 2019. Therefore, staff is proposing an adjustment in all fees, which would increase the basic application fee from \$2,458 to \$2,497.

ANALYSIS

The final budget reflects an increase in the overall operating budget. This is due to an adjustment to costs for outside consultants and CALAFCO dues. Workload estimates are expected to be similar to last fiscal year. Staff is anticipating a low level of applications that will be paid for by the applicants, with an estimate of four applications.

The individual line items which changed from last year's budget are discussed below.

REVENUES:

This budget shows an increase of approximately 8% compared to last year's budget.

RECOMMENDATION

Staff recommends that the Commission:

- 1. Approve the final budget for Fiscal Year 2019/2020 (Exhibit A)
- 2. Approve a 1.6 percent increase in the fee schedule (Exhibit B) in accordance with the increase in the consumer price index.

SCHEDULE OF FEES AND CHARGES

(Effective July 1, 2019)

In accordance with Government Code Sections 56383, the Madera LAFCo has discretion to establish a schedule of fees for the costs of proceedings. The schedule of fees shall not exceed the estimated reasonable cost of providing the service and shall be imposed pursuant to Government Code Section 66016.

It is the policy of the LAFCo not to accept a resolution or petition application for a change of organization, reorganization, or sphere of influence amendment until all applicable processing and/or petition checking fees have been deposited with the Executive Officer.

With respect to studies of special district changes of organization or reorganization performed at the request of an individual or entity, it is the policy of the Commission that the individual or entity that requests the changes of organization or reorganization shall be responsible for payment of the applicable fee at the time of application.

It is the policy of the LAFCo that any processing or petition checking fees are mandatory and non-refundable unless specifically waived by a majority vote of the Commission.

In addition to the LAFCo fees and charges, there are in some cases State of California Fish and Game Fees and fees which are applicable in order to formally record an approved application with the State Board of Equalization.

BACKGROUND

At the March 27, 2019 meeting, the Commission discussed a possible increase to the \$100 stipend that the Commissioner's currently receive for attending LAFCO Meetings. The increase that was considered was to raise the stipend from \$100 to \$125 and to raise the Chairman's stipend to \$150.

ISSUE

Section 1.27 of the Madera LAFCO Policies, Guidelines and Procedures Manual currently states the following:

Commission members and alternates shall receive a stipend of \$100.00 (pending BOS approval) for each meeting attended and shall be reimbursed for other reasonable and necessary expenses incurred in performing the duties of their office.

- It appears that the Commissioners have been receiving a stipend of \$100 per meeting since at least 2002.
- The County Planning Commission, Airport Land Use Commission and Assessment Appeals Board members all currently receive \$100 per meeting.
- At the March 27 meeting it was mentioned that the Air Pollution Control District Board was in the process of raising their stipend from \$100 to \$200 per meeting.
- Attached is a survey of stipends received by other LAFCO Commission's in California.
