## E. EDUCATIONAL PRESENTATION

Annette Presley, LCSW, BHS Division Manager introduced Alex Addo Boateng, Director of Perinatal Mental Health Integration Project. Alex reported on the scope of innovation for Project Dad: traditionally most services target Mothers; therefore, *Project Dad*, an innovative pilot program will strategically outreach and support Fathers in settings that traditionally target mothers, infants, and children. - AB 1976 Mental Health Services Assisted Outpatient Treatment: Annette Presley, LCSW, BHS, AOD, Division Manager, shared a power point presentation and requested the support in opting out of implementing AB 1976 Mental Health Services Assisted Outpatient Treatment.
- 2. Action Item: Behavioral Health Services Department (BHS) is requesting support for a Resolution request from Madera County Board of Supervisors to Opt Out of Implementing AB 1976 Mental Health Services Assisted Outpatient Treatment, in Madera County. There is no additional funding to implement AB 1976, has costs that would be a burden to local court system, BHS has services that are similar in its current service delivery system and it does not address the unmet behavioral health needs of our county. Chairman Steve Mortimer made the recommendation to opt out, Eric Oxelson, Board Member made a motion to support the recommendation to opt out and Nancy Lyday, Board member second the motion. Action was adopted
- 3. Consideration of Re-appointment of Behavioral Health Board Member Eric Oxelson for a three-year term, beginning 04/01/2021 04/01/2024. Nancy Lyday, Board Member moved to re-appoint Eric Oxelson, and Dawn Swinton Garcia, 2<sup>nd</sup> the motion. Sabrina will submit the Board Letter to the Board of Supervisors. Action was adopted.

## 2. BEHAVIORAL HEALTH SERVICES (BHS) PROGRAM REPORTS

Oakhurst Counseling Center (OCC) – Greg Gregson, LMFT, BHS Supervising Mental Health Clinician. Greg has been with Madera County for 18 years and has been a supervisor for 14 years. OCC serves a full spectrum of clients. Currently there are 9 employees, 3 therapist, 3 case managers 1 Vocational Assistant Driver, and they are in the process of adding one additional pre licensed clinician. The average case load is 70-90. The goal is for clients to become stable. The challenges lie in a lack of resources due to mountain living.

## H. DIRECTOR'S REPORT – Connie Moreno-Peraza, MSW, LCSW, Director, Behavioral Health Services

Connie Moreno-Peraza, Director of Behavioral Health Services provided updates on the following priority areas that she is focusing on since her arrival in Madera County: COVID-19 Staff Reintegration Plan; full implementation of new Electronic Health Record, *inSync;* planning for Mental Health Month; assessing BHS Department infrastructure to prepare for future requirements by CalAIM, Governor Gavin Newsom initiative "California Advancing and Innovating Medi-Cal"; finalizing FY21-22 Budget; and collaborating with multiple departments and agencies in Madera County; planning for Opioid Epidemic pilot project to develop "Community Crisis Response Teams" in Madera County. More information will be shared at the May 19, 2021 regarding planning for CalAIM, since it is a very important initiative and will impact BHS greatly in the coming years, plus an update on the two planning sessions in May for Community Crisis Response Teams state pilot.
