COMMENTS

This budget funds the cost of the County's mail room services. The mail room serves all County Departments except offices located outside the immediate Madera area. The mailroom has a postage machine and a folding machine available to serve County Departments. This division is administered by the County Clerk-Recorder's Office.

ESTIMATED REVENUES

Services To Other Agencies (\$2,500) is recommended based on Maintenance Districts share of postage costs.

670000 Intrafund Revenue (\$25,000) is recommended unchanged and is based on subvented departments share of postage costs.

SALARIES & EMPLOYEE BENEFITS

710102 Permanent Salaries (\$37,755) is recommended increased \$150 based on cost of recommended staff.

710103 Extra Help (\$30,000) is recommended to fund extra help salaries.

Retirement (\$14,895) reflects the County's anticipated contribution to Social Security and the Public Employees' Retirement System.

710300 Health Insurance (\$9,089) is based on the employer's share of health insurance premiums.

710400 Workers' Compensation (\$514) reflects the Department's contribution to the County's Self-Insurance Internal Service Fund.

SERVICES & SUPPLIES

720300 Communications (\$250) is recommended to fund the mailroom telephone line.

720800 Maintenance - Equipment (\$250) is recommended for potential maintenance and repairs of mail room equipment.

SERVICES & SUPPLIES (continued)

- **Office Expense** (\$2,250) is recommended reduced \$12,750 to fund the County's Post Office Box rental, shredder services, and other mail room supplies. Certain expenses have been moved to budget 00210 and 01330 as they related to non-mailroom expenses.
- **721302** Office Expense Postage (\$245,000) is recommended increased \$5,000 based on current usage for postage and mail services for all County Departments, except Social Services and offices located outside the Madera area.
- **721303** Office Expense Purchasing Agent Store (\$0) is recommended reduced. This expense has been moved to budget 00230.
- **721400** Professional & Specialized Services (\$0) is not recommended.
- Professional & Specialized Services-Software Maintenance (\$0) is not recommended in this budget. This expense has been relocated to the Information Technology budget 00240. This service provides Computer Consultation for the Property Tax System (Megabyte). The service will provide ongoing software maintenance enhancements to the programs and additions/deletions to the Property Tax System Programs when there are County changes or new laws.
- **Rents & Leases County Vehicles** (\$200) is recommended for the use of vehicles from the Central Garage. This expense is recommended reduced due to the relocation of several equipment leases to account 730330 and to budget 00210.
- **721700** Rents & Leases Buildings (\$0) is not recommended.
- **721900** Special Department Expense (\$500) is recommended for miscellaneous Departmental supplies.
- **Transportation & Travel** (\$500) is recommended for postal training on newly required regulations and other mail room functions.
- **Rents & Leases Equipment** (\$19,865) is recommended for leases of the internal postage meter, inserter/folder, binding machine and copier.
