This budget, Org Key 04047, was created by the Board in Fiscal Year 2018-19. The original grant was for three years and expired on June 30, 2020. The grant was renewed for an additional three years with a new expiration date of June 30, 2023. It continues to fund a School Resource Deputy for Chawanakee Unified School District.

ESTIMATED REVENUES

St-Grant Revenue (\$105,000) is recommended based on the projected available funding from the grant.
