This budget, Org Key 04048, was created by the Board in Fiscal Year 2018-19. The original grant was for three years and expired on June 30, 2020. The grant was renewed for an additional three years with an expiration date of June 30, 2023. It continues to fund a School Resource Deputy for Yosemite Unified School District.
