# F. EDUCATIONAL PRESENTATION

Mattie Mendez, Executive Director, Madera County Action Partnership (MCAP) on Homelessness in Madera County. Elizabeth Wisener, Community Services Program Manager, MCAP presented a power point presentation which shared the Homeless Assessment link (see attached pptx). Elizabeth described the steps to receiving housing services and the challenges. Mattie shared about the project of Respite Care for the homeless post hospitalization. The Madera Rescue Mission will be the site where there will be modular

homes will be placed. The new program that is being investigated is housing for transitional age youth ages 18-24. MCAP is currently seeking units to lease to start the program. The HELP Center that was originally located at 800 E. Yosemite is not at 1225 Gil Avenue.

# b. Ad Hoc Committees

- 1. Strategic Planning (Karen Scott) Karen reported on how important it is for families to check on loved ones who might be going through mood swings. Instead of rejecting them, find out if they are taking their medication and be supportive.
- Outreach (\*Loraine Goodwin) Reported on the lack of services by Cleveland and how there is a need or additional services at the Hope House. Loraine also wants to have a way to identify homeless people who will work as safe. Loraine also discussed investigating a way that fathers can work with children if the child has a way of being safe, such as reporting pedophilia and not being battered.

# I. DIRECTOR'S REPORT – Connie Moreno-Peraza, MSW, LCSW, Director, Behavioral Health Services

Connie Moreno-Peraza, Director of Behavioral Health Services provided updates on:

- 1. BHS Staff Reintegration to be on site from Teleworking for the past year and half. Staff have been on site since June 16, 2021.
- 2. BOS approved the BHS Budget for FY21-22 with no questions or concerns.
- 3. inSync, vendor for BHS Electronic Health Record System, was on site at 209 E. 7th Street Madera to provide technical assistance to staff and to focus on completing three key contract deliverables to be prepared for upcoming EQRO and Triennial Compliance Reviews. (can you align #3 with the other numbers?)
- 4. Madera Community Hospital and BHS are collaborating on a project to co-locate BHS clinician or substance abuse counselor to the Emergency Department to help reduce the number of 5150's and SUD related admissions.
- 5. There will be a CalAIM presentation tomorrow 6/17/2021 by CBHDA Executive Director, Michelle Cabrera so we have a clear understanding and foundation on what CalAIM entails and impacts on Madera County. All BHB members have been invited. Please join the Zoom presentation if you are available.
- 6. Managed Care Plans and BHS are working on developing a plan to provide In Lieu of Services (ILOS), which may include funding for a Sobering Center and/or a Respite Care facility which is also part of the homeless/housing committee priority area.
- 7. HMA Community Crisis Response Teams (CRT) is a two-county pilot project, including Madera County and Sutter-Yuba County to help address the opioid crisis and plan for the use of Narcan to reduce overdoses.
- 8. Peer Certification Workgroup will be established within BHS. You will be invited to participate as soon as we get Department of Health Care Services guidelines, regulations, etc. Lori Prentice has a team and is interested in participation.

9. BHS has completed its first and initial Draft of a Dashboard. A power point presentation was put together to show the initial data. A more final dashboard and presentation will be provided in the Fall-Winter of 2021.
