Local Availability of Paxlovid for New COVID-19 Cases

Situational Update

Madera County is currently receiving more Paxlovid than is being prescribed, despite an ongoing significant number of new COVID diagnoses. Providers may not be aware of the current availability of Paxlovid. Paxlovid is recommended for those who are older (i.e., over age 65) or those with the relatively common underlying medical conditions listed below. Given how common these medical conditions are, we suspect Paxlovid is being underutilized due to a lack of awareness of the current availability.

Paxlovid Availability

Paxlovid Is Recommended For

Paxlovid[™] is authorized for the treatment of mild-to-moderate COVID-19 in adults and pediatric patients (12 years of age and older weighing at least 40 kg) with positive results of direct SARSCoV-2 viral testing, and who are at high risk for progression to severe COVID-19, including hospitalization or death.

<u>Persons Who are Older or With Medical Conditions Listed Below are Candidates</u> <u>for Treatment</u>

Age (<u>risk increases with each decade after age 50)</u>, cancer, cardiovascular disease, chronic kidney disease, chronic lung disease, diabetes, immunocompromising conditions or receipt of

immunosuppressive medications, obesity (body mass index ≥30), pregnancy, and sickle cell disease.

Prescribing Information:

- Two 150 mg tablets (300 mg) of Nirmatrelvir, with one 100 mg tablet of Ritonavir taken orally for 5 days
- Without regard to food
- As soon as possible after COVID-19 diagnosis and within 5 days of symptom onset.
- Each carton contains five blister packs, one for each day
- Dose reduction needed for moderate renal impairment

There are drug interactions, however, as treatment with Paxlovid is only for 5 days, many medicines can be held and restarted after completion. The website https://www.covid19-druginteractions.org/checker makes checking for drug interactions simple.

Health Update: Provides updated information regarding an incident or situation; unlikely to require immediate action

Health Information: Provides general health information which is not considered to be of emergent nature
