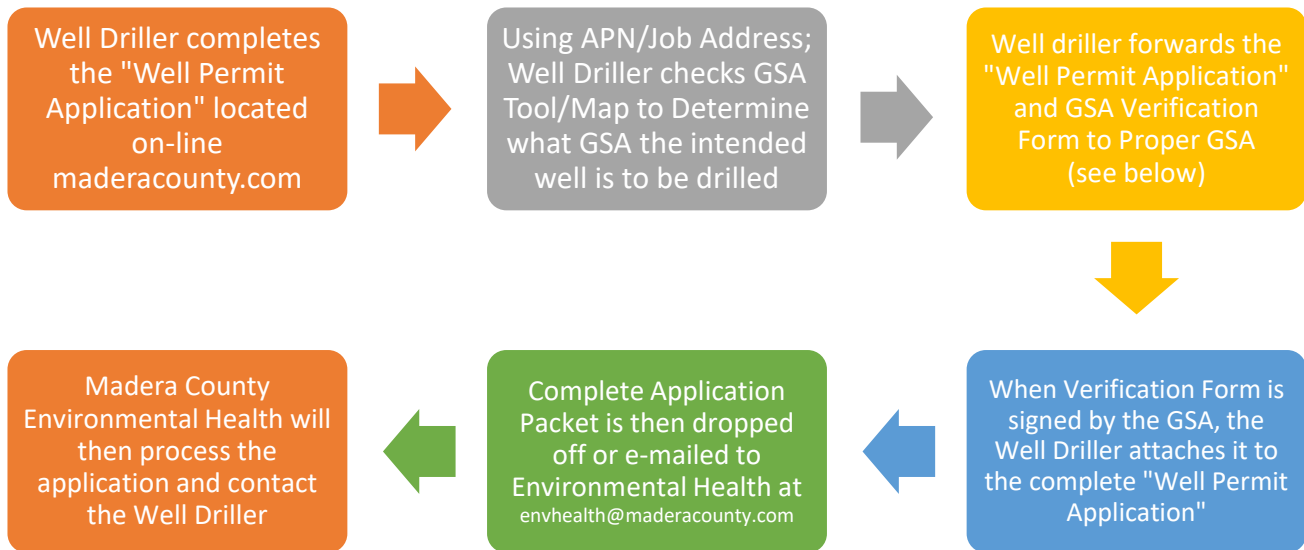


# Governor's Executive Order #N-7-22 Well Permit/GSA Verification Process



**MAKE NOTE:**

- This Process is only required for new or alteration of existing Ag wells
- A signed Verification Form by the GSA does not guarantee approval of the well permit.
- This does not apply to wells that will provide less than 2-acre-feet per year of groundwater for individual domestic users or public water systems.
