Using APN/Job Address; Well Driller checks GSA Tool/Map to Determine what GSA the intended well is to be drilled



Well driller forwards the
"Well Permit Application
and GSA Verification
Form to Proper GSA

Madera County
Environmental Health will
then process the
application and contact
the Well Driller



Complete Application Packet is then dropped off or e-mailed to Environmental Health at envhealth@maderacounty.com



When Verification Form is signed by the GSA, the Well Driller attaches it to the complete "Well Permit Application"

- > This Process is only required for new or alteration of existing Ag wells
- A signed Verification Form by the GSA does not guarantee approval of the well permit.
- This does not apply to wells that will provide less than 2-acre-feet per year of groundwater for individual domestic users or public water systems.
