#### **PUBLIC HEARINGS:**

## \*1. GUARCHARAN RAKKAR – CONDITIONAL USE PERMIT (CUP #2013-012) – MADERA (District #2)

Gurcharan Rakkar is requesting a conditional use permit (CUP #2013-012) to allow an amendment to conditional use permit (CUP #2012-022) to allow an additional 894 square feet of covered outdoor space with a kitchen to a religious facility. The property is owned by Gurdwara Parmeshar Dwar LLC and is located on the north side of Avenue 14, approximately 0.22 mile west of the intersection of Avenue 14 and Road 23 ½ (23249 Avenue 14), Madera. The property is zoned AR-5 (Agricultural, Rural-5 Acre) District. A previously approved Mitigated Negative Declaration (MND #2012-28) has been prepared concerning the proposed project in compliance with provisions of the California Environmental Quality Act (CEQA). Size: 6.68 acres. APN: 045-081-013.

# \*2. PACIFIC ETHANOL MADERA, LLC – PARCEL MAP (PM #4172) & VARIANCE (VA #2013-001) AND SETBACK VARIANCE (ZV #2013-001) - MADERA (District #3)

Pacific Ethanol Madera, LLC is requesting a division of 137.08 acres (PM #4172) into two parcels (13.41 acres and 123.68 acres). The property is located on the south side of Avenue 12 at the southwest corner of its intersection with Santa Fe Drive (31470 Avenue 12), Madera. A variance (VA #2013-001) to allow a 3:1 length to width ratio for lot configuration and a setback variance (ZV #2013-001) to allow a 0'0" side setback. A draft Mitigated Negative Declaration (MND #2013-16) has been prepared concerning the proposed project in compliance with provisions of the California Environmental Quality Act (CEQA). Size: 137.03 acres. APN: 047-130-020.

## \*3. BERTHA GILL – PARCEL MAP (PM #4171) & REZONE (CZ 2013-001) - MADERA (District #1)

Bertha Gill is requesting a division of 7.68 acres (PM #4171) into two parcels (2.4 acres and 4.84 acres). The property is located on the northwest corner of the intersections of Road 28 ½ and Avenue 14 ½ (14580 Road 28 ½), Madera. A rezoning (CZ #2013-001) will also be considered to comply with the Madera County General Plan. The zone is AR-5 (Agricultural, Rural-5 Acre) District. The proposed zone is IL (Industrial, Urban or Rural Light) District. A draft Mitigated Negative Declaration (MND #2013-15) has been prepared concerning the proposed project in compliance with provisions of the California Environmental Quality Act (CEQA). Size: 7.68 acres. APN: 035-191-053.

#### PLANNING COMMISSION MEETING PROCEDURES

Planning Commission meetings are conducted under the direction of the Chairman. Each item scheduled for public hearing at a Planning Commission meeting will be announced by the Chairman, and the hearing will be conducted as follows:

- 1. The Planning staff will present their report and recommendation on the matter being heard. Commission members will be provided an opportunity to question staff.
- 2. The Chairman will first ask the project applicant or proponent to present any points they feel the Commission should understand about their proposal. The Commission may ask questions.
- 3. The Chairman will ask those in support and then those opposed to the application to come to the podium and present any testimony they wish to give in regard to the proposal being considered.
- 4. The Chairman will offer the project applicant an opportunity for rebuttal of any testimony against the proposal or to clarify information previously presented.
- 5. The public comment portion of the hearing will be closed and the matter will be deliberated by the Commission and a decision will be rendered.

#### **RULES FOR PRESENTING TESTIMONY**

All persons who wish to present testimony to the Planning Commission in a public hearing must observe the following rules:

- 1. All testimony must be presented from the podium. When beginning to speak, first identify yourself, place of residence, and interest in the matter. This is required for the public record. Since all meetings are tape recorded, please speak clearly and use the microphone provided.
- 2. All remarks must be addressed to the Chair. Conversation or debate between a speaker at the podium and a member of the audience or staff is not permitted.
- 3. Please keep your remarks as brief as possible. Focus your testimony on the most important facts you wish to be considered. Avoid duplicating testimony provided by others.
- 4. Planning Commission hearings can involve highly emotional issues, so it is important that all participants conduct themselves with courtesy, dignity, and respect.
- 5. Whenever possible, written testimony should be presented as well as oral. Written testimony should be submitted for Planning Commission consideration in advance of the actual hearing date.
