***1. JOHN C. REISBIG – CONDITIONAL USE PERMIT (CUP #2013-017) - OAKHURST
(District #) Lead Planner: Robert Mansfield**

John C. Reisbig is requesting a Conditional Use Permit (CUP #2013-017) to allow operation of a bed and breakfast facility. The property is located on the southwest side of Maples Lane, approximately 808 feet west of its intersection with Nelder Heights Drive (42382 Maples Lane), Oakhurst. The property is zoned RMS (Residential, Mountain, Single Family) District. A draft Mitigated Negative Declaration (ND #2013-21) has been prepared concerning the proposed project in compliance with provisions of the California Environmental Quality Act (CEQA). Size: 2.94 acres. APN: 057-230-050. This project is located in the Oakhurst Area Plan.

***2. VELOCITY IRON & METAL, INC. – GENERAL PLAN (GP #2013-001) &
CONDITIONAL USE PERMIT (CUP #2013-011) - MADERA

Velocity Iron & Metal, Inc. is proposing to amend the Madera County General Plan (GP #2013-001) pursuant to Section 65358 of the Government Code. The area to be considered consists of 19.62 acres located at the intersection of Road 24 and Avenue 19 ½ (19427 Road 24), Madera. The proposal would amend the area now shown as A (Agriculture) Designation to LI (Light Industrial/Business Park) Designation. A Conditional Use Permit (CUP #2013-011) will also be considered to allow a recycling center. The property is owned by Jose Alejandro Hernandez, Jr. A draft Negative Declaration (ND #2013-23) has been prepared concerning the proposed project in compliance with provisions of the California Environmental Quality Act (CEQA). Size: 19.62 acres. APN's: 029-210-011, 029-210-050, & 029-210-010.

Castellina LLC is proposing to amend the Madera County General Plan (GP #2013-003) pursuant to Section 65358 of the Government Code. The area to be considered consists of 792.55 acres located north of Avenue 17 between Road 27 and Road 28 ½ (no address available), Madera. The proposal would amend the area now shown as AE (Agricultural Exclusive) Designation to NGA (New Growth Area) Designation for a future Specific Plan. The property is owned by Herman Revocable Trust 2008, Kevin Lee Herman, and Diane Patricia Herman. A draft Negative Declaration (ND #2013-22) has been prepared concerning the proposed project in compliance with provisions of the California Environmental Quality Act (CEQA). Size: 792.55 acres. PLANNING COMMISSION MEETING PROCEDURES

Planning Commission meetings are conducted under the direction of the Chairman. Each item scheduled for public hearing at a Planning Commission meeting will be announced by the Chairman, and the hearing will be conducted as follows:

1. The Planning staff will present their report and recommendation on the matter being heard. Commission members will be provided an opportunity to question staff.
2. The Chairman will first ask the project applicant or proponent to present any points they feel the Commission should understand about their proposal. The Commission may ask questions.
3. The Chairman will ask those in support and then those opposed to the application to come to the podium and present any testimony they wish to give in regard to the proposal being considered.
4. The Chairman will offer the project applicant an opportunity for rebuttal of any testimony against the proposal or to clarify information previously presented.
5. The public comment portion of the hearing will be closed and the matter will be deliberated by the Commission and a decision will be rendered.

RULES FOR PRESENTING TESTIMONY

All persons who wish to present testimony to the Planning Commission in a public hearing must observe the following rules:

1. All testimony must be presented from the podium. When beginning to speak, first identify yourself, place of residence, and interest in the matter. This is required for the public record. Since all meetings are tape recorded, please speak clearly and use the microphone provided.
2. All remarks must be addressed to the Chair. Conversation or debate between a speaker at the podium and a member of the audience or staff is not permitted.
3. Please keep your remarks as brief as possible. Focus your testimony on the most important facts you wish to be considered. Avoid duplicating testimony provided by others.
4. Planning Commission hearings can involve highly emotional issues, so it is important that all participants conduct themselves with courtesy, dignity, and respect.
5. Whenever possible, written testimony should be presented as well as oral. Written testimony should be submitted for Planning Commission consideration in advance of the actual hearing date.
