DIRECTOR'S REPORT

1. FY22-23 BUDGET

- a. DBHS Budget was approved by the Board of Supervisors on Monday June 13, 2022. 195 Full Time Positions were approved; 25 of those 195 positions are funded by CalAIM DHCS, DSH, SABG, Tribal Council, Medi-Cal, Realignment funded positions.
- b. DBHS needs to build infrastructure in the Administrative Divisions, Crisis Continuum Services, Peers and Family Partners, and Substance Abuse Counselor integration in all programs, and Prevention, Education, Outreach and Engagement services to increase awareness and access to services, suicide prevention, MHSA, and Cultural Competence. Contracts Management needs attention in relation to compliance with all DHCS audits and reviews this past year. MHSA needs its own unit as well being a significant portion of our annual budget.

2. CalAIM

- a. Crisis Care Mobile Unit, CCMU, grant is under implementation and planning to ensure for county wide crisis and non-crisis response services for Madera County residents.
 - i. Westcare contract is pending final review to go to the BOS later this month or early July, as they will provide these crisis services after hours, night shift, holidays, and weekends. County BHS will provide these services during the day. There will be 3 shifts to ensure for timely response to crisis and non-crisis in the community. We will partner with Law Enforcement and many partners in the community as well as Madera Community Hospital and Valley Children's Hospital. We received award of close to \$4 million dollars under this grant.
- b. BHQIP, Behavioral Health Quality Improvement Program, will focus on the Electronic Health Record full implementation and compliance with DHCS reporting requirements. We received \$250,000 to build infrastructure to implement all requirements. This funding is included in Budget section. All counties got this \$250, 000 to start planning.





3. Mental Health Services Act (MHSA)
 - a. We are in the second year of the 3 Year MHSA Plan. We are taking to the Board of Supervisors our Annual Plan for approval. This annual plan update is due to DHCS on 6/30/22. Nick Avila-Montes, LCSW, Adult System of Care Division Manager, will provide update and will report that we did not receive any input from the community during the 30-Day Public Comment Period.
 - b. The plan for FY22-23 is to hire an MHSA Supervisor and Administrative Analyst that will work closely as a unit under BHS to closely monitor and report on all MHSA Components (PEI, CSS, CFTN, INN), and work closely with fiscal and program teams to complete all required reports and reviews in a timely fashion. This area needs attention to ensure we implement an expenditure plan, so we can meet the needs of the communities we serve in Madera County and to prevent any reversion of unspent funds. This plan of hiring dedicated staff is part of my plan to build infrastructure in our department, which is common in other county organizational structures.
4. Community Assistance Recovery Empowerment Court (CARE Court)
 - a. CBHDA is actively involved in providing input on Governor Newsom's initiative to reduce homelessness and focusing on the most chronic diagnoses on the Schizophrenia Spectrum and focusing on the important of a Housing Plan for all eligible persons for this upcoming program. We are advocating for sufficient funding, housing options, workforce, and infrastructure as well.
 - b. CARE Court is a multidisciplinary approach to this problem and will required all departments, courts, justice programs, and community agencies to work together in order for this program to be successful
5. 988 Mental Health Crisis Hot Line
 - a. CBHDA is actively providing input and advocating for county behavioral health to be included in the discussions on how this bill will roll out at the local level.
 - b. There is momentum but no definite timeline yet for when counties have to fully launch 988 Crisis Hot Line.
6. Community Response Team: Harm Reduction to Reduce Fentanyl Overdoses & Save Lives
 - a. HMA consulting group is continuing to work with Madera County on this initiative.
 - b. Data report shows multiple trainings in the community and distribution of Narcan kits.





7. Workforce

- a. We currently have 24 vacancies and continue to be successful in filling key positions.
- b. With the new budget that was approved, we have started to plan the recruitments this week. We plan to advertise in targeted sites and collaboration with Human Resources to expedite filing these positions.
- c. We also plan to use non-traditional strategies to recruit like distributing flyers at the universities, use word of mouth, ask our staff to help us recruit. They are key to our success in recruiting and retaining excellent staff.

DISCUSSION / FISCAL IMPACT / STRATEGIC FOCUS:

DISCUSSION:

Proposition 63 was passed in 2004 and became the Mental Health Services Act (MHSA) law in 2005. This law generates funding for public mental health services through a 1% tax on personal income over \$1 million. Over the past years this funding has provided for new and innovative mental health services, during an economic downturn that generated greater mental health service needs. It has helped increase

access to underserved communities through providing funding that allowed the Madera County Behavioral Health Services (MCBHS) to implement more culturally appropriate service modalities.

The MHSA Three-Year plan and annual updates provide a projection of services and resources that will be provided to communities through MHSA funding. County Mental Health Departments are required to annually develop and present description of their MHSA services and funding, based on State projections, for community stakeholder review and recommendations. This annual update provides a progress report for MCBHS' services for the previous fiscal years, outcomes for the previous years, an overview of proposed MHSA services for the current Three-year plan, program descriptions, and projected expenditures.

In accordance with State mandates and in order for counties to receive funds, Madera County Behavioral Health Services is required to submit a Three-Year Program and Expenditure Plan or Update and obtain necessary approvals to enter into a valid MHSA Performance Contract with the Department of Healthcare Services. DISCUSSION:

Mental Health Management I, Inc., operates a State-licensed Mental Health Rehabilitation Center (MHRC) and Institutions for Mental Diseases (IMD). These facilities provide varying degrees of residential care services for adults with severe and persistent mental illness. Aside from hospitalization and State Hospital placement, an IMD provides the highest level of care (in a secured facility) available for mental health clients. Clients may be placed in such a facility following hospitalization for transitional or long-term residential care.

It is often difficult to find appropriate residential placement for mentally ill residents of

- Community Assistance, Recovery and Empowerment (CARE) Court is a new framework to get people with mental health and substance use disorders the support and care they need.
- CARE Court is aimed at helping the thousands of Californians who are suffering from untreated mental health and substance use disorders leading to homelessness, incarceration or worse.
- California is taking a new approach to act early and get people the support they need and address underlying needs - and we're going to do it without taking away people's rights.
- CARE Court includes accountability for everyone – on the individual and on local governments – with court orders for services.

HOW CARE COURT WORKS


CALIFORNIA'S CARE COURT

Community Assistance, Recovery and Empowerment (CARE) Court is Governor Newsom's new plan to get Californians in crisis off the streets and into housing, treatment, and care.



ACTING EARLY TO GET PEOPLE THE SUPPORT THEY NEED

CARE Court is aimed at helping Californians who are suffering from untreated mental health and substance use disorders leading to homelessness, incarceration or worse. Each person is connected with a court-ordered Care Plan and Supporter for up to 24 months.



SETTING THEM UP WITH AN INDIVIDUALIZED CARE PLAN

CARE Court connects a person with a care team in the community and can include clinically prescribed, individualized treatment with supportive services, stabilizing medication, and a housing plan.

CARE Court connects a person struggling with untreated mental illness – and often also substance use challenges – with a court-ordered Care Plan for up to 24 months. Each plan is managed by a care team in the community and can include clinically prescribed, individualized interventions with several supportive services, medication, and a housing plan. The client-centered approach also includes a public defender and supporter to help make self-directed care decisions in addition to their full clinical team



CARE Court is designed on the evidence that many people can stabilize, begin healing, and exit homelessness in less restrictive, community-based care settings. It's a long-term strategy to positively impact the individual in care and the community around them. The plan focuses on people with schizophrenia spectrum and other psychotic disorders, who may also have substance use challenges, and who lack medical decision-making capacity and advances an upstream diversion from more restrictive conservatorships or incarceration.

The court-ordered response can be initiated by family, county and community-based social services, behavioral health providers, or first responders. Individuals exiting a short-term involuntary hospital hold or an arrest may be especially good candidates for CARE Court. The Care Plan can be ordered for up to 12 months, with periodic review hearings and subsequent renewal for up to another 12 months. Participants who do not successfully complete Care Plans may, under current law, be hospitalized or referred to conservatorship - with a new presumption that no suitable alternatives to conservatorship are available.

All counties across the state will participate in CARE Court under the proposal. If local governments do not meet their specified duties under court-ordered Care Plans, the court will have the ability to order sanctions and, in extreme cases, appoint an agent to ensure services are provided.

CARE Court builds on Governor Newsom's \$14 billion multi-year investment to provide 55,000 new housing units and treatment slots as well as a more than \$10 billion annual investment in community behavioral health services. The Governor's comprehensive approach combines a focus on bridge housing to quickly rehouse unsheltered individuals with behavioral health issues, all while more new units come online, while also transforming Medi-Cal to provide more behavioral health services to people struggling the most.
