DISCUSSION / FISCAL IMPACT / STRATEGIC FOCUS:

DISCUSSION:

Crestwood Behavioral Health, Inc. (Crestwood) operates several types of State-licensed facilities including Mental Health Rehabilitation Centers (MHRCs), Institutes for the Mentally Disordered (IMDs) and sub-acute non-IMDs. These facilities provide varying degrees of residential care services for adults with severe and persistent mental illness. Clients may be placed in such a facility following hospitalization for transitional or long-term residential care.

Behavioral Health Services (BHS) has contracted with Crestwood since 2003. It is often difficult to find the appropriate residential placement for Madera County BHS clients and

Crestwood offers the opportunity for BHS to place clients in the facility most appropriate for the level of care they require. Placement in mental health facilities is usually of an urgent nature and it is important BHS has options available to ensure appropriate placement for Madera County Clients.

DISCUSSION / FISCAL IMPACT / STRATEGIC FOCUS:

DISCUSSION:

On March 1, 2011 your Board approved the consolidation of the Madera County Mental Health and Alcohol Advisory Boards into a single Behavioral Health Board that convened on July 1, 2011. The authority for the Mental Health Board is provided by the State of California pursuant to Section 5604 of the Welfare and Institutions Code, so in combining the Boards we were mandated to continue to maintain a Board with a

minimum of ten members citing mental health concerns as their primary reason for serving on the Board.

Legislation requires that Board members shall have a professional interest in or a personal commitment to mental health issues and/or alleviating problems related to alcohol/drug abuse in the community. Each of the recommended appointments is in accordance with this criteria.

The goal is to have equal representation from each district as stipulated within Article V our Bylaws which states in part:

There shall be an equal number of appointees by each member of the Board of Supervisors. Each Supervisor shall appoint two members that cite mental health issues as their primary reason for serving on the Behavioral Health Board, and one member that cites AOD issues as their primary concern. The Board may recommend appointees to the Board of Supervisors.

Ms. Hicks resides and will represent District No. 2 and Ms. Avila resides in District No. 3 however we are seeking her appointment as a representative for District No. 1.

Ms. Avila appointment was intended to fill the remaining term left by deceased Chuck Doud who term expires November 11, 2022. Ms. Hicks appointment was intended to fill the remaining vacancy in District No. 2 left by the resignation of Andrea Shepherd on September 14, 2021. The recommended action will correct the appointee's term and meet the requirements of the BHB bylaws.

The Behavioral Health Board unanimously approved the recommendation of Bertha Avila and Wendy Hicks at their June 15, 2022 meeting.

There is one (1) vacancy that remains to be filled for the district listed below. One representative needed for Mental Health issues on behalf of Districts No. 4.

1. District No. 4: Vacancy left by Karen Marie Scott (deceased), term ending April 1, 2023. (Mental Health)

On September 14, 2010, Madera County on behalf of Behavioral Health Services (BHS) entered into an agreement with Denham Resources as the employer of record for Madera County residents that self-identify themselves as mental health clients or family members, to work in a peer capacity as a Community Services Liaison (CSL). The Mental Health Services Act (MHSA) mandates the use of peers with lived experience to work in a support capacity with BHS clients and families. Current and future CSL's will continue to need work experience in order to transition into permanent positions.

Denham Resources pays the hourly wage of up to 14 CSLs and charges BHS an
