First Human Case of West Nile Virus in Madera County - 2022

Situational Update

The Madera County Department of Public Health (MCDPH) is reporting the first human case of West Nile virus (WNV) disease in Madera County for the 2022 mosquito season, which usually starts in the summer and continues through late fall. MCDPH is alerting clinicians that there is evidence of mosquitoes currently transmitting WNV locally - as the Madera County Mosquito & Vector Control District has also detected mosquitoes infected with WNV for the current season. Please see actions requested of clinicians (below).

Actions Requested of Clinicians

- Consider mosquito-borne diseases in persons presenting with fever, headache, muscle pain, joint point, rash, vomiting, diarrhea, or acute neurologic illness who have had recent exposure to mosquitoes.
- ➤ If you suspect WNV infection, send serum samples for WNV specific IgM. If neurologic disease is present, also send a CSF sample for WNV specific IgM testing. WNV IgG titers are not diagnostic for a current WNV infection.
 - If the initial WNV IgM test is negative and WNV infection is still suspected, obtain a repeat serum IgM titer approximately 10 days later.
- ➤ Health care providers should notify their local health department immediately of any possible cases; for Madera County patients call 559-675-7894 to report a possible case.
