The Political Reform Act prohibits a person appointed to the Local Agency Formation Commission from accepting gifts, or promise of gifts, of more than \$520.00 within the preceding 12 months from parties, participants, or their agents while a proceeding is pending before LAFCO. LAFCO Commissioners who receive such contributions are required to disqualify themselves from participating in the proceedings. Both Commissioners and contributors who are parties to the proceeding are required to disclose the contributions received or made.
