SUBJECT:

LAFCO Work Program 2022-2023 - Municipal Service Review Updates

### **PROPOSAL**

Staff is proposing to the Commission a work program for recommended Municipal Service Review updates.

## **BACKGROUND**

The Spheres of Influence for all special districts and cities are required to be reviewed, if necessary, every five years (Government Code §56425). If it is deemed by the local LAFCO that an update to the Sphere of Influence is required, a Municipal Service Review (MSR) must be prepared, reviewed, and adopted by the Commission prior to any significant revision to a Sphere of Influence for a city or special district.

Generally, municipal service reviews consist of a comparison of the adequacy of services being offered by agencies, and a recommendation as to which agencies, or reorganization of which agencies, could best provide the required municipal services. The scope and depth of these reviews are suggested by State Guidelines.

The work program for FY 2022-2023, which is attached, indicates that at least one MSR has now been conducted on all the special districts in the County, with the exception of five County Service Areas (CSA): three of these (CSA 7, 9, and 13) only provide for road maintenance and two (CSA 5 and 14) provide other services but are quite small in area.

During 2022 MSRs were completed on the Madera and Chowchilla Cemetery Districts, the Madera County Mosquito and Vector Control District, the Chowchilla Memorial Healthcare District, and the Bass Lake/North Fork Area. The approval of the Bass Lake/North Fork MSR signified the completion of the first round of MSRs for all the special districts in the County, with the exception of the few small CSAs noted above. The second round of MSRs began

with the completion of the MSR for the Cemetery Districts and the Chowchilla Memorial Healthcare District and Madera County Mosquito and Vector Control District MSR.

The Commission adopted a policy in December 2018 regarding future MSRs that the Commission would determine which Districts/Cities to evaluate based on either the length of time since the last review and/or changes/issues that have arisen within a given District/City that would warrant an MSR.

Based on this policy, staff recommends that an MSR be conducted on the nine water/irrigation districts in the County. A comprehensive MSR of all the water districts was last conducted in 2008. Recently there have been many water related issues in Madera County and the State of California has passed the Sustainable Groundwater Management Act (SGMA) which placed a heighted awareness on the preservation of groundwater resources. Therefore, it seems appropriate to conduct an MSR on these districts.

LAFCO has budgeted \$35,000 in the 2022-2023 FY budget for consultant services for the preparation of Municipal Service Reviews. Staff believes that the budgeted amount should cover the cost of the recommended MSR.

### **RECOMMENDATION**

Staff recommends that the Commission direct staff to conduct a Municipal Service Review on the nine water/irrigation Districts in Madera County:
