7. **NEW MATTERS**

<u>Triangle T Water District Annexation and Sphere of Influence Expansion</u> (File No 2022-03)

Proposed is the annexation of approximately 3,062 acres (24 parcels) into the Triangle T Water District. The application also proposes to expand the Triangle T Water District's Sphere of Influence (SOI) to add approximately 11,293 acres to its Sphere of Influence. This property is generally located easterly of the San Joaquin River between the Avenue 10 and Avenue 21 alignment.

The proposed Sphere of Influence Expansion involves property currently within the SOI of Madera Irrigation District, Chowchilla Water District, and Clayton Water District. The SOI Expansion proposal also includes the proposed removal of these properties from within the SOI of those neighboring water districts.
