*1. BIOREM ENERGY- CONDITIONAL USE PERMIT (CUP #2016-008) - CHOWCHILLA (DISTRICT #2) LEAD PLANNER: ROBERT MANSFIELD

Biorem Energy, is requesting a Conditional Use Permit (CUP #2016-008) to allow an anaerobic bio-digester for an existing dairy operation. The property is owned by Vlot Brothers and is located on the northwest corner of the intersection of Avenue 21 and Road 4 (3197 Avenue 21), Chowchilla. The property is zoned ARE-40 (Agricultural, Rural, Exclusive-40 Acre) District. A draft Mitigated Negative Declaration (MND #2016-15) has been prepared concerning the proposed project in compliance with provisions of the California Environmental Quality Act (CEQA). *2. ROGER LEACH – CONDITIONAL USE PERMIT (CUP #2016-013) – MADERA (DISTRICT #1) LEAD PLANNTER: BECKY BEAVERS

Roger Leach is requesting a Conditional Use Permit (CUP #2016-013) to allow a church facility and charter school expansion. The property is owned by Valley West Christian Center and is located on the northeast corner of the intersection of Owens Street and Adell Street (26339 Adell Street), Madera. The property is zoned AR-5 (Agricultural, Rural-5 Acre) District. A draft Mitigated Negative Declaration (MND #2016-17) has been prepared concerning the proposed project in compliance with provisions of the California Environmental Quality Act (CEQA). Size: 4.95 acres. APN's: 038-100-009 and 010.

*3. EMBREE ASSET GROUP, JOHN SHEILDS – CONDITIONAL USE PERMIT (CUP #2016-011) – MADERA (DISTRICT #5) LEAD PLANNER: JOEY DINH

Embree Asset Group, John Shields is requesting an amendment to Conditional Use Permit (CUP #93-07) by Conditional Use Permit (CUP #2015-013) to allow a proposed Dollar General (retail) with associated parking. Building size is to be a one story 9,100 square feet. A Variance (VA #2016-001) will also be considered to allow for 28 parking spaces, where 37 parking spaces are required by ordinance. The property is owned by Maria G. Camin, Henri A. and Maria G. Rev Trust 2011, and Henri A. Camin. The property is located on the northeast corner of the intersection of Highway 41 and Road

417 (no address available), Coarsegold. The property is zoned PDD (Planned Development District) District. The Conditional Use Permit (CUP #2015-013) application was previously reviewed at the June 7, 2016 Planning Commission meeting but was returned to staff to request additional information A draft Mitigated Negative Declaration (MND #2016-16) has been prepared concerning the proposed project in compliance with provisions of the California Environmental Quality Act (CEQA). PLANNING COMMISSION MEETING PROCEDURES

Planning Commission meetings are conducted under the direction of the Chairman. Each item scheduled for public hearing at a Planning Commission meeting will be announced by the Chairman, and the hearing will be conducted as follows:

- 1. The Planning staff will present their report and recommendation on the matter being heard. Commission members will be provided an opportunity to question staff.
- 2. The Chairman will first ask the project applicant or proponent to present any points they feel the Commission should understand about their proposal. The Commission may ask questions.
- 3. The Chairman will ask those in support and then those opposed to the application to come to the podium and present any testimony they wish to give in regard to the proposal being considered.
- 4. The Chairman will offer the project applicant an opportunity for rebuttal of any testimony against the proposal or to clarify information previously presented.
- 5. The public comment portion of the hearing will be closed and the matter will be deliberated by the Commission and a decision will be rendered.
- 6. Persons wishing to appeal a decision must present a written notice of appeal together with the fee to the planning commission secretary whose office is located at the Madera County Government Center 200 West 4th Street, 3rd floor, Madera CA. The notice and fee must be received within 15 days of the date the decision is rendered

RULES FOR PRESENTING TESTIMONY

All persons who wish to present testimony to the Planning Commission in a public hearing must observe the following rules:

- 1. All testimony must be presented from the podium. When beginning to speak, first identify yourself, County of residence, and interest in the matter. This is required for the public record. Since all meetings are recorded, please speak clearly and use the microphone provided.
- 2. All remarks must be addressed to the Chair. Conversation or debate between a speaker at the podium and a member of the audience or staff is not permitted.
- 3. Please keep your remarks as brief as possible. Focus your testimony on the most important facts you wish to be considered. Avoid duplicating testimony provided by others.
- 4. Planning Commission hearings can involve highly emotional issues, so it is important that all participants conduct themselves with courtesy, dignity, and respect.
- 5. Whenever possible, written testimony should be presented as well as oral. Written testimony should be submitted for Planning Commission consideration in advance of the actual hearing date.
