- 2. The Classified Service Salary Schedule is hereby amended as outlined in Exhibit "A".

- 3. The Peace Officer & Related Classifications Salary Schedule is hereby amended as outlined in Exhibit "B".
- 4. The Unclassified Salary Schedule is hereby amended as outlined in Exhibit "C".
- 5. The Salary Tables for the bargaining units, unrepresented employees, and department heads, and for the Peace Officer & Related Classifications that includes the 3.5% COLA are hereby amended as outlined in Exhibit "D".
- 6. Except as otherwise amended, all other provisions of Resolution 2022-203 shall remain in full force and effect. This amendment to the Resolution shall take effect as of May 1, 2023.
