Consideration to adopt a Resolution designating River Vista Behavioral Health to provide psychiatric evaluation and treatment of persons under the Lanterman-Petris-Short Act.

DISCUSSION / FISCAL IMPACT / STRATEGIC FOCUS:

DISCUSSION:

Under the Lanterman-Petris-Short (LPS) Act and California Welfare and Institutions Codes (WIC) 5150, 5585.50, and 5585.55, an individual can be involuntarily placed in custody for 72-hour evaluation and treatment at a facility designated by the county and approved by the California Department of Health Care Services (DHCS). DHCS requires County Board of Supervisors to determine which facilities in their county shall be designated and authorized as LPS facilities. Upon the County Board of Supervisors' decision to designate a facility, a formal resolution is documented and submitted to DHCS Mental Health Licensing and Certification department. This request is for the Madera County Board of Supervisors to approve the designation of River Vista Behavioral Health as an LPS 5150/5585.50 facility.

River Vista Behavioral Health is owned and operated by Universal Health Services, Inc. (UHS). UHS operates 26 acute care hospitals, 335 behavioral health facilities, 39

outpatient facilities and ambulatory care access points, and various related services located in 30 U.S. states, Washington D.C., Puerto Rico and the United Kingdom.

In accordance with the California Code of Regulations (CCR), Title 22, clients who are either a danger to themselves or others as stipulated within WIC 5150 and WIC 5585 may be admitted to River Vista Behavioral Health on a voluntary or involuntary basis. All acute inpatient psychiatric services will be in accordance with CCR Title 22, Division 5, Part 1 & Part 1.5, Chapter 2.

The Board's approval of the recommended Resolution will update the State approved WIC 5150/5585 designated mental health facilities in the County to meet State mandates to provide facilities with the necessary staff and equipment appropriate to respond to individuals experiencing a mental health crisis.

FISCAL IMPACT:

River Vista Behavioral Health is a private entity; therefore, there will be no impact to the County's General Fund.

DISCUSSION / FISCAL IMPACT / STRATEGIC FOCUS:

DISCUSSION:

Mental Health America (MHA) launched Mental Health Week (which eventually became Mental Health Month) in 1949 to educate Americans about mental illness and raise awareness about the conditions and the importance of mental wellness. Each year Behavioral Health Services requests that the Board of Supervisors sign a Proclamation proclaiming May as Mental Health Matters Month. As of May 2023, the Madera Maternal Wellness coalition has requested the Board to join them in recognizing Maternal Mental Health week, proclaiming the week of May 1st through May 7th as Maternal Mental Health Awareness week in Madera County.

This proclamation demonstrates Madera County's support of May 2023 as Maternal Mental Health week. It encourages all citizens, government agencies, public and private institutions, businesses, hospitals, and schools in Madera County to recommit to our communities to increase awareness and understanding of mental illness. Mental Health week is celebrated throughout the United States and raises awareness about maternal illnesses, encompassing perinatal mood and anxiety disorders (PMAD). It also draws attention to black maternal mental health and maternal suicide prevention which is oftentimes overlooked.

To date, medical and mental health providers, communities, and families still do not understand the nuances of PMAD. Some people still only associate PMAD with postpartum depression and perinatal psychosis. Approximately 1 in 7 pregnant people while perinatal anxiety affects approximately 11% to 21% of people, and 19% of those people express ideation's of self-harm. According to Kidsdata.org, in 2015, 16% of Madera County women reported symptoms of PMAD. Please note, families of color are unlikely to report, and this is data prior to the pandemic.

Since 2012, the Madera County Maternal Wellness Coalition has continued to combat stigma associated with PMAD. The MWC aims to continue providing resources for the community, training's for medical and mental health providers on screening and best practices as well as awareness materials.

Your approval of this Proclamation will recommit Madera County's increased awareness and understanding of maternal mental illness and the ability to meet the need for appropriate and accessible services.

DISCUSSION / FISCAL IMPACT / STRATEGIC FOCUS:

DISCUSSION:

California Psychiatric Transitions, Inc. (CPT) operates a State-licensed Mental Health Rehabilitation Center (MHRC) and Institutions for Mental Diseases (IMD) facility. These facilities provide varying degrees of residential care services for adults with severe and persistent mental illness. Aside from hospitalization and State Hospital placement, an IMD provides the highest level of care (in a secured facility) available for mental health clients. Clients may be placed in such a facility following hospitalization for transitional or long-term residential care.

It is often difficult to find appropriate residential placement for mentally ill residents of Madera County. Placement in mental health facilities is usually of an urgent nature since there are currently no residential mental health facilities in Madera County. It is important that Madera County Department of Behavioral Health Services (MCDBHS) has options available to ensure appropriate placement for seriously mentally ill residents

DISCUSSION / FISCAL IMPACT / STRATEGIC FOCUS:

DISCUSSION:

Davis Guest Home (DGH) operates State-licensed Residential Care Facilities (RCF) for adults. RCF's represent the lowest level of care for individuals who are not able to live independently, but do not require higher levels of care, such as those provided in an Institution for Mental Disease. If clinically appropriate, individuals can transition from DGH to independent living.

It is often difficult to find appropriate residential placement for mentally ill residents of Madera County. There are few residential facilities in the Central Valley specializing in mental health care and none in Madera County. Madera County Department of Behavioral Health Services (MCDBHS) have been contracting with DGH for several years and have been very pleased with the services they provide for our clients.

The requested amendment is to remove the total compensation amount for FY 2023-2024.

combining the Boards we were mandated to continue to maintain a Board with a minimum of ten members citing mental health concerns as their primary reason for serving on the Board.

Legislation requires that Board members shall have a professional interest in or a personal commitment to mental health issues and/or alleviating problems related to alcohol/drug abuse in the community. Each of the recommended appointments is in accordance with this criteria.

The goal is to have equal representation from each district as stipulated within Article V of our Bylaws which states in part:

There shall be an equal number of appointees by each member of the Board of Supervisors. Each Supervisor shall appoint two members that cite mental health issues as their primary reason for serving on the Behavioral Health Board, and one member that cites AOD issues as their primary concern. The Board may recommend appointees to the Board of Supervisors.

Ms. Avila resides in District 3, but since we already have three representatives from District No. 3, we are seeking her reappointment to represent District No. 1, Mr. Torres both resides in and would represent District No. 4, and Ms. Prentice resides in District No. 5 however we are seeking her reappointment as a representative for District No. 4.

The Behavioral Health Board unanimously approved the recommendation of Bertha Avila, Joe Torres and Lori Prentice at their May 17, 2023 meeting.

There are two (3) vacancies that remain to be filled for the districts listed below. Two representatives needed for Mental Health issues on behalf of Districts No. 1 and No. 2 and one representative needed for AUD/SUD on behalf of District No. 1.

1. District No. 1: Vacancy left by the resignation of Nina Zarucchi-Mize. Term now expired. (Mental Health)
2. District No. 2: Vacancy left by the resignation of Glenna Jarvis. Term ending July 1, 2023. (Mental Health)
3. District No. 1: Vacancy left by the expiration of term of Sadek Alammari. Term now expired. (AOD/SUD)

Madera County Department of Behavioral Health Services (MCDBHS) continues to focus on key strategic priorities to ensure Madera County residents eligible for mental health, alcohol and drug, or co-occurring services get high quality care in all our sites throughout the county in Madera, Chowchilla and Oakhurst. Some of the key priorities we are working on are Excellent Customer Service and Welcoming Environments, Qualified and Diverse Workforce, Timely Access, Mobile Crisis Services, Quality of Care, Equity, Budget, Efficiency, Compliance, Technology, Community Partnerships, and Housing the Homeless with Behavioral Health Conditions. Below are updates on some of the priority areas in the department.

BUDGET

Governor Gavin Newsom released the FY23-24 Budget May Revision on May 12, 2023. The May Revise Behavioral Health Themes and Highlights are listed below which were provided by CBHDA Executive Director, Michelle Cabrera, on May 13, 2023.

- **Behavioral Health Payment Reform remains intact as proposed:** Proposed funding of \$375 million in state General Fund (GF) to support county behavioral health's payment reform initiative and the transition from Certified Public Expenditures (CPEs) to Intergovernmental Transfers (IGTs) remains a part of the Governor's proposed budget.
- **CalBH-CBC rebranded "BH-CONNECT":** The Administration has renamed the California Behavioral Health Community-Based Continuum (CalBH-CBC) Demonstration "BH-CONNECT" and includes a new behavioral health workforce initiative to be funded by state-level MHTSA and federal funds. The BH-CONNECT demonstration application is expected to be released for stakeholder review this summer.
- **MHTSA Re-structure proposal:** The May Revise does not include additional detail regarding the restructure proposal
The Governor did refer during the press conference to a slide entitled "Behavioral Health Bond" for an unspecified amount to:
 - Modernize the MHTSA
 - To treat mental illness, substance abuse, and homelessness
 - State-of-the-art residential settings in community
 - Housing for homeless veterans



MAY BUDGET REVISE CONTINUED

- **CalAIM Jail In-Reach:** \$410 million in new PATH funding to support planning and implementation of pre-release and reentry services, along with \$109 million in funding for FY 2023-24.
- **CARE Court:** Proposes modest additional funds to support county behavioral health CARE Court implementation, including \$15 million one-time start-up funding for Los Angeles County, as well as ongoing increased funding of approximately \$60 million. Negotiations with counties continue to refine estimates.
- **Recoupments:** Proposed recoupment of \$253 million from county behavioral plans for psychiatric inpatient and immigration related claims continues.
- **Behavioral Health Continuum Infrastructure (BHCIP):** Proposed delay continues of Round six grants to 2024-25 totaling \$480.7 million.
- **Bridge Housing:** The May Revise proposes to no longer delay the last portion of funding but to instead remove the state GF and replace it with state-level MHSA admin funding.
- **Workforce Funding:** Continues to propose delays of \$68 million in 2022-23 and \$329.4 million in 2023-24 for certain HCAI healthcare workforce programs.
- **Opioid Settlement Funds:** Proposes \$32 million from federal opioid settlement fund in addition to the \$35 million in GF allocated in the budget to support statewide access to naloxone, including for every school in California.
- **Homelessness and Housing:** Additional \$1 billion for homelessness to local governments with policy changes to increase accountability.

MADERA COUNTY DEPARTMENT OF BEHAVIORAL HEALTH SERVICES PROPOSED BUDGET FY23-24

The MCDDBHS Proposed Budget will be heard the week of June 12-16, 2023, at Madera County Board of Supervisors Chambers for Budget Public Hearings. The proposed budget is \$45, 363, 265.00, which includes a total number of 215 FTE county positions (Full Time Equivalent).

WORKFORCE

Currently, there are 195 approved positions in our department's budget FY22-23. We have filled 135 full time positions. There are twenty-five vacancies and thirty-four are pending requisitions out for recruitment. We continue to recruit at job fairs, targeted sites, state associations, colleges, universities, Indeed, Government Jobs, licensing boards, and word of mouth recruitment strategies are used as well.

TIMELY ACCESS

Currently, we are working on process improvements to reduce the wait times for SUD assessments by assigning an SUD Counselor to only do Alcohol and Drug Assessments and to develop Treatment Tracks for timely placement in Outpatient Treatment Groups or refer placements to our current contractors. Mental Health Assessments are under the 10-days wait time at two Madera sites and Chowchilla. However, the Oakhurst Clinic is at 11 days wait time for assessments. The SUD Assessments do not have

the 10-day requirement; however, we are working to align the wait times with the mental health expectation as well. The current wait times for SUD assessments range from 2 days at 7th Street Clinic, to 22 days at Oakhurst, to 75 days in Chowchilla. Workforce has been the main reason causing the delays for SUD assessments. We plan to show improvement by the end of June 2023 and thereafter.

HOUSING THE HOMELESS

MCDBHS has developed a Housing Services Capacity Management Report with distinct types of housing options for behavioral health clients. This report has been particularly useful as we work towards reducing homelessness in our programs and as we work towards implementing the recently approved Homeless Strategic Plan for Madera County. A copy of this report is attached for your reference.

QUALITY

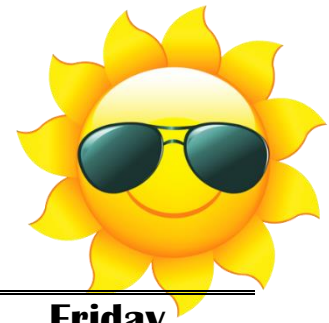
MCDBHS has also developed a Residential Placements Capacity Management Report and Inpatient Facilities Management Report to monitor the quality of care being provided to our clients. We plan to develop a process to check on our clients with a set frequency for those in residential placements to ultimately see if we can place them closer to their homes and we plan to evaluate the number of clients placed in inpatient psychiatric facilities, so we can maximize the future River Vista Behavioral Health Psychiatric Hospital that is scheduled to open later in June 2023. With this local resource, it will help keep our clients with 5150/5585 locally and near their loved ones and with more successful placement options.

INITIATIVES

May is Mental Health Month. The national theme is “Look Around, Look Within,” with a focus on our Mental Health and Wellness. We have a conference and a resource fare, which are scheduled for Friday May 19, 2023. Green Ribbons are provided to you to show support for this important initiative in our county and in the world. Staff Health and Wellness is a key priority in our department, and we have plans to improve our staff’s health by devoting a room for their Relaxation, Debriefing, and Decompressing, when needed so they can re-charge and help provide the highest quality of care for our clients. Credible Mind contract will also be approached for all staff to retake the Burnout Survey, so we can plan more activities for our staff. More information to be provided later this year.

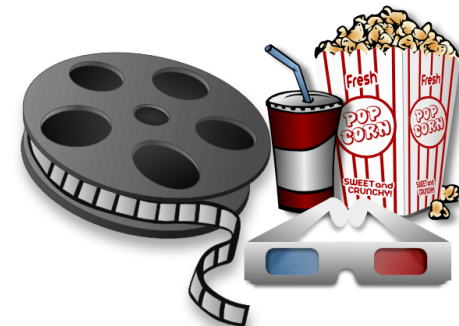

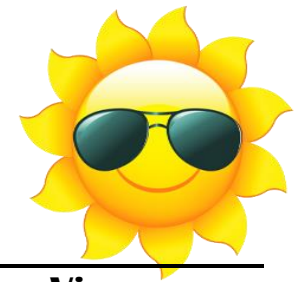
