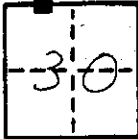

PHYSICAL DESCRIPTION OF CORNER FOUND; EVIDENCE AND METHOD USED TO IDENTIFY OR REESTABLISH

FOUND AND ACCEPTED: A 3" dia., octagonal brass cap, up 1/2" in a 1'dia.
Concrete slab flush with the ground. Corner position
established by PG&E Co. (LS 2756) in 1971 by subdivision
of section procedure.

PHYSICAL DESCRIPTION OF MONUMENTS REBUILT OR PERPETUATED

Built a rock mound 2 1/2' x 2 1/2' x 1/2' high around monument. Set a metal post with Forest Service
monument signs attached 4' ± NW of monument.

- 4. A White Oak, 6" dia., bears N 11° 03'W, 67.30'.

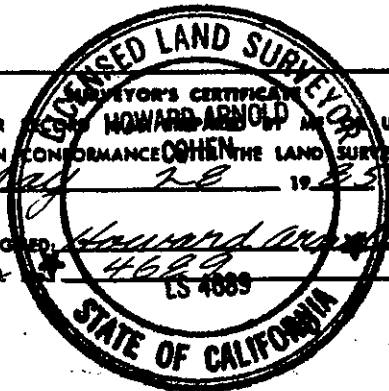

- . Corner lies 1 1/2' Nw of a fence corner with fences running E'ly & S'ly.
- . Corner lies 180' ± W of the centerline of road 222 (Auberry Road).
- . Bearings are to the center of trees at the base. Distances are horizontal to a nail and tag (stamped LS 4689) driven into the side center of the root crown.
- . Posted Forest Service Monument and Bearing Tree signs, on trees #1, #3, and #4.
