WHEREAS, Section 2.60.165 of the Madera County Code authorizes, except as otherwise provided by State Law, the compensation of officers and employees be established by Resolution of the Board of Supervisors; and

WHEREAS, in December 2022, Resolution 2022-203 was adopted, thereby establishing the County of Madera salary and fringe benefit schedules, and was most recently amended on July 11, 2023, by Resolution 2023-105;

WHEREAS, pursuant to CalPERS' regulations on Publicly Available Pay Schedules (2 CCR § 570.5), the County is required to maintain a publicly available, duly approved and adopted pay schedule for all CalPERS members that shows the current payrate for each identified position; and

WHEREAS, Resolution 2022-203, as amended by Resolution 2023-105, now requires an update to the Elected Officials' Salary Schedule to reflect the current salaries for the County's elected officials, which, as previously determined by Resolution and Ordinance No. 530G, are calculated as a percentage of, and subject to change with, the salary in effect for a Superior Court Judge.

**NOW**, **THEREFORE**, **BE IT RESOLVED** by the Board of Supervisors of the County of Madera, a political subdivision of the State of California, that the following is adopted:

- The above Recitals are incorporated by reference and are made a substantive part of this Resolution.
- 2. The Elected Officials' Salary Schedule is hereby amended as outlined in Exhibit "A" attached hereto.
- Except as otherwise amended in Exhibit "A," all other provisions of Resolution 2022-203, as most recently amended by Resolution 2023-105, shall remain in full force and effect.

This amendment to the Resolution shall take effect immediately.
