DISCUSSION:

God's Love Outreach Ministries (G.L.O.M.) will provide Adult Residential Facility services to Madera County residents. G.L.O.M. will provide all individuals housed in the designated units for over seven days with an individualized treatment and rehabilitative plan (ITRP). G.L.O.M. attempts to create a supportive family environment for participants. G.L.O.M. believes everyone has intrinsic value. G.L.O.M.'s philosophy is to meet each participant where they are to help them along the process of successful reentry, recovery, or stability. The program will work with participants that have mentored in their community, have shown to be positive influences, and/or participated in a Peer Mentor Coaching Programs. This will be a group of people who will support continued growth and offer corrections and strategies for participants to reduce recidivism and achieve recovery and/or stability while enhancing the community.

DISCUSSION / FISCAL IMPACT / STRATEGIC FOCUS:

DISCUSSION:

On December 13, 1994, your Board authorized the Mental Health Department (now Madera County Department of Behavioral Health Services (MCDBHS)) to administer the Madera County Mental Health Plan for psychiatric inpatient services. As the Mental Health Plan administrator, MCDBHS authorizes inpatient care for Madera County Medi-Cal recipients who require psychiatric hospitalization. Aside from State Hospital placement, psychiatric hospitalization is the highest level of care for individuals with a serious mental illness (SMI).

Madera County contracts with several psychiatric hospitals for inpatient services. Hospitalization is of an urgent nature, and it is important that MCDBHS has options available to ensure appropriate placement for SMI residents of Madera County. This contract permits BHC Fremont Hospital to provide psychiatric inpatient care to Medi-Cal beneficiaries and indigent residents who reside in Madera County and are not covered by other third-party payors.

It has helped increase access to underserved communities through providing funding that allowed the Madera County Department of Behavioral Health Services (MCDBHS) to implement more

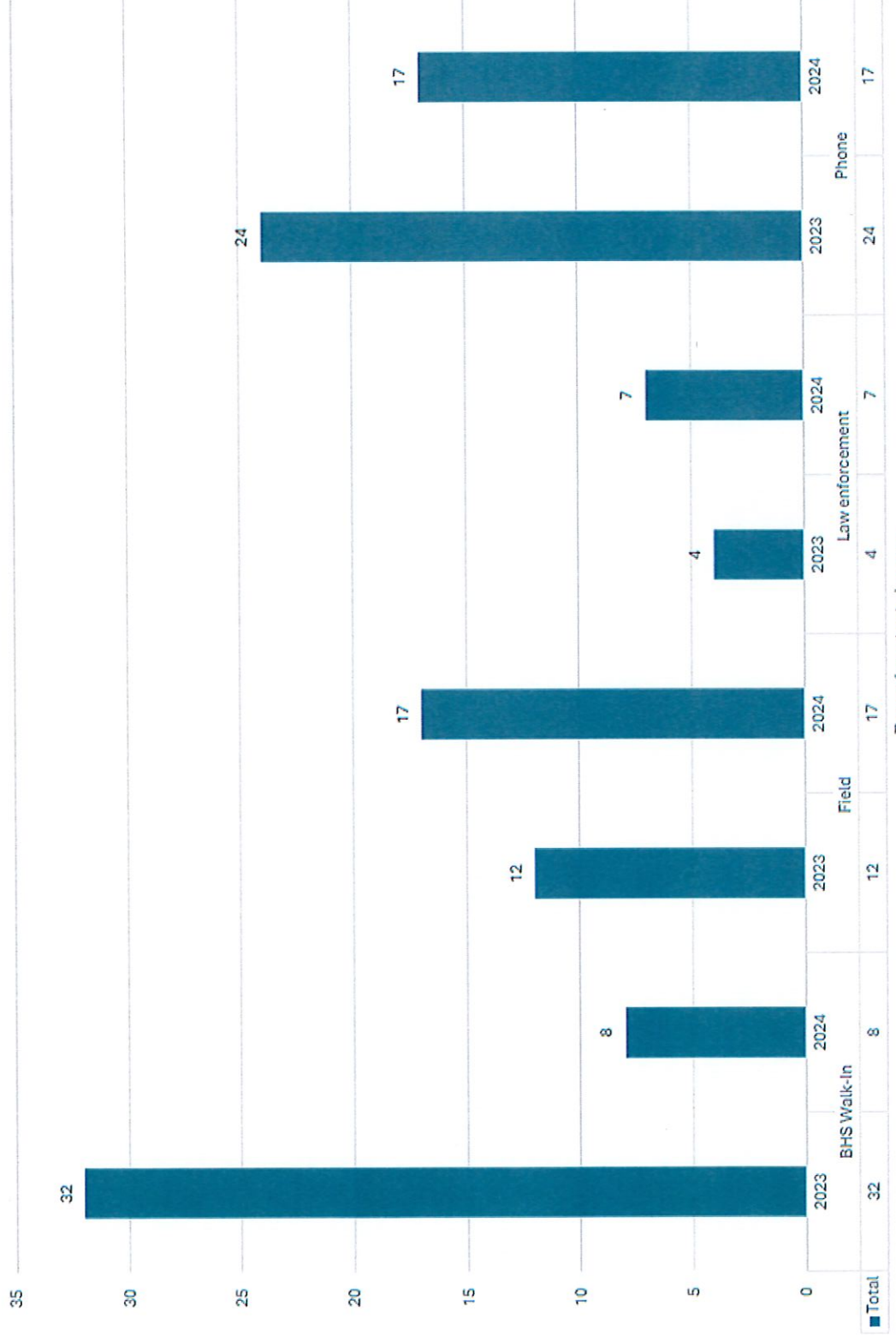


CARES Outreach to Homeless 2023-2024



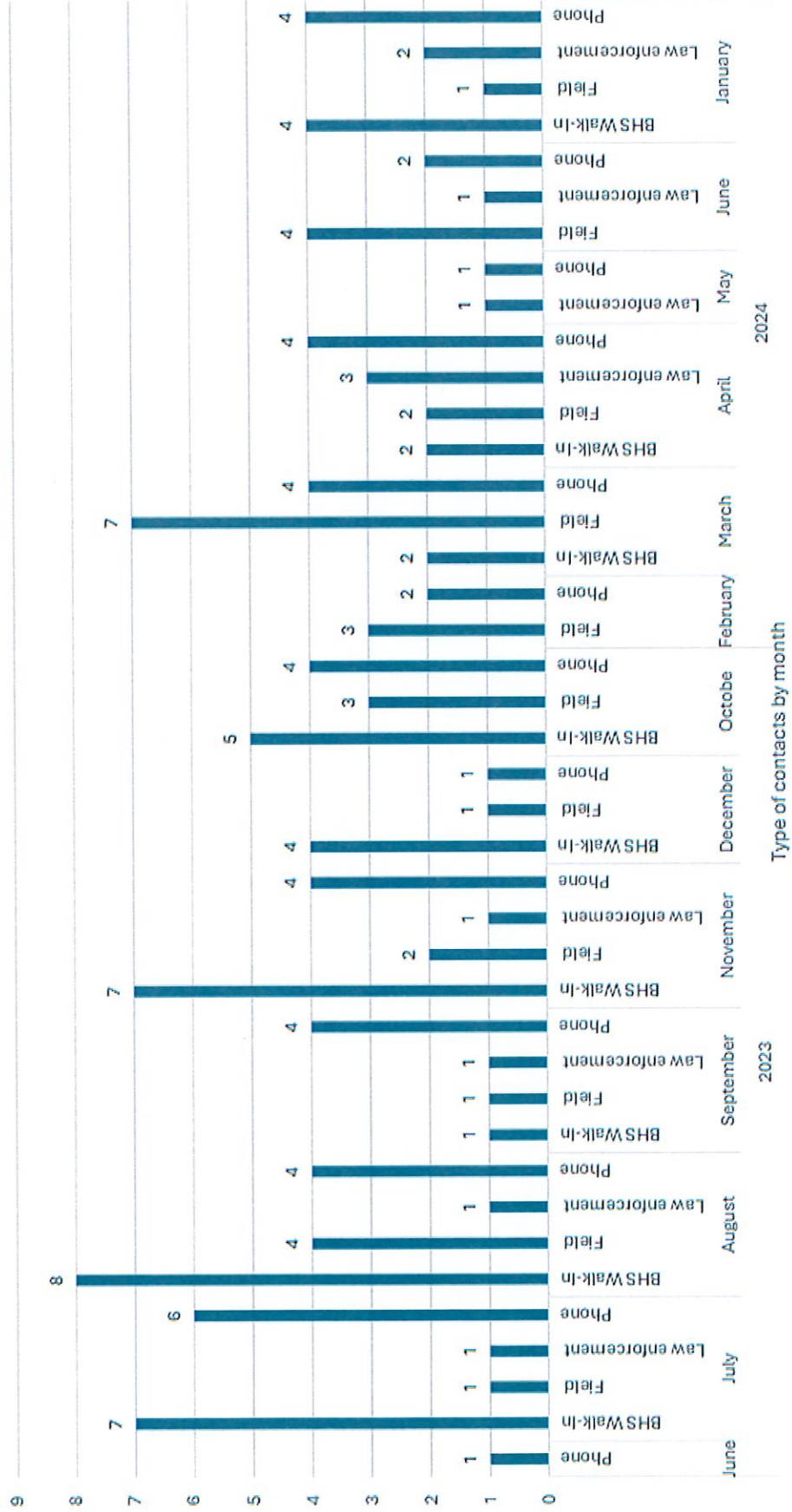


CARES Outreach to Homeless
7/1/2023 to 7/31/2024



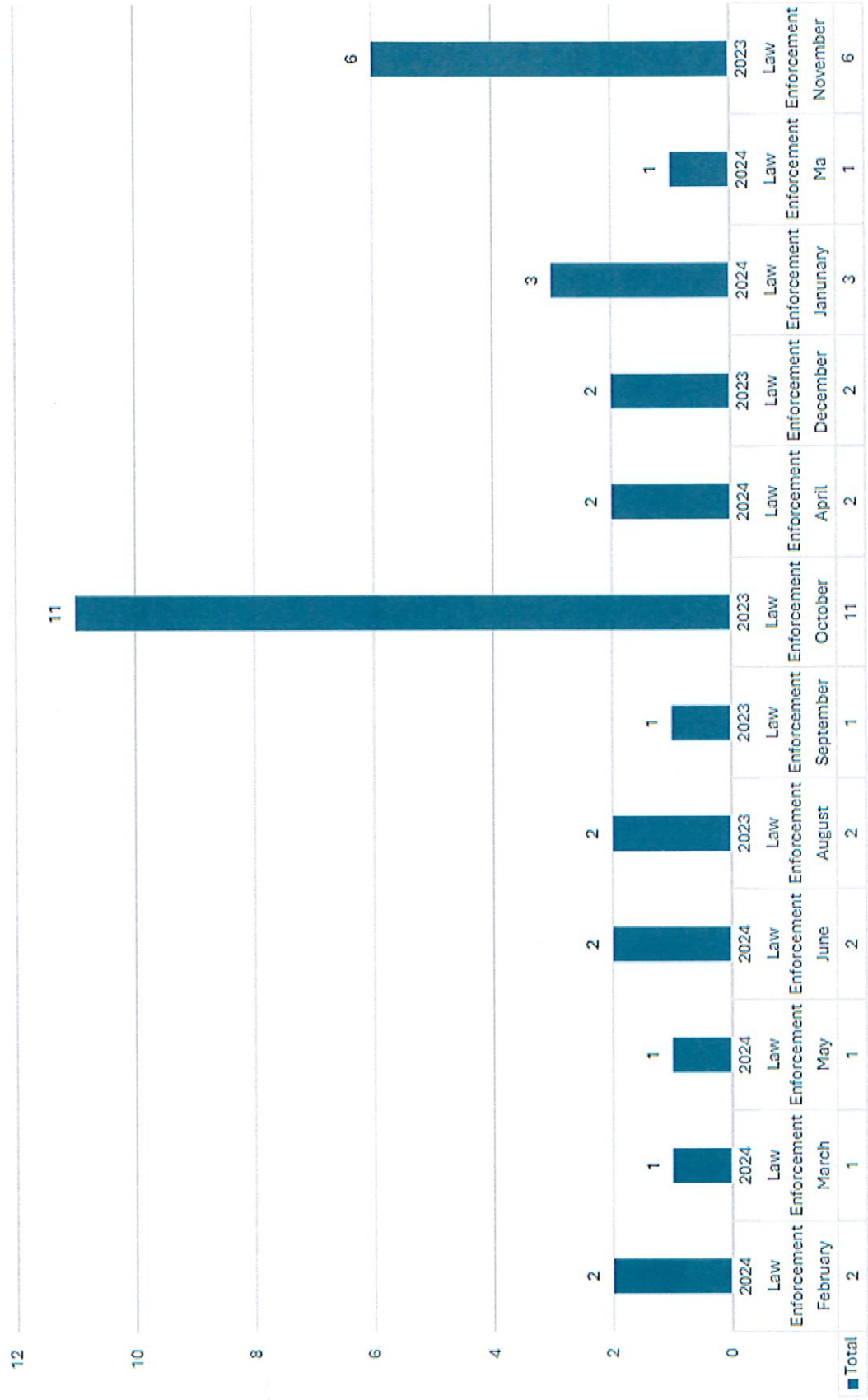

AB109 Outreach to Homeless contacts 7/2023 to 7/2024

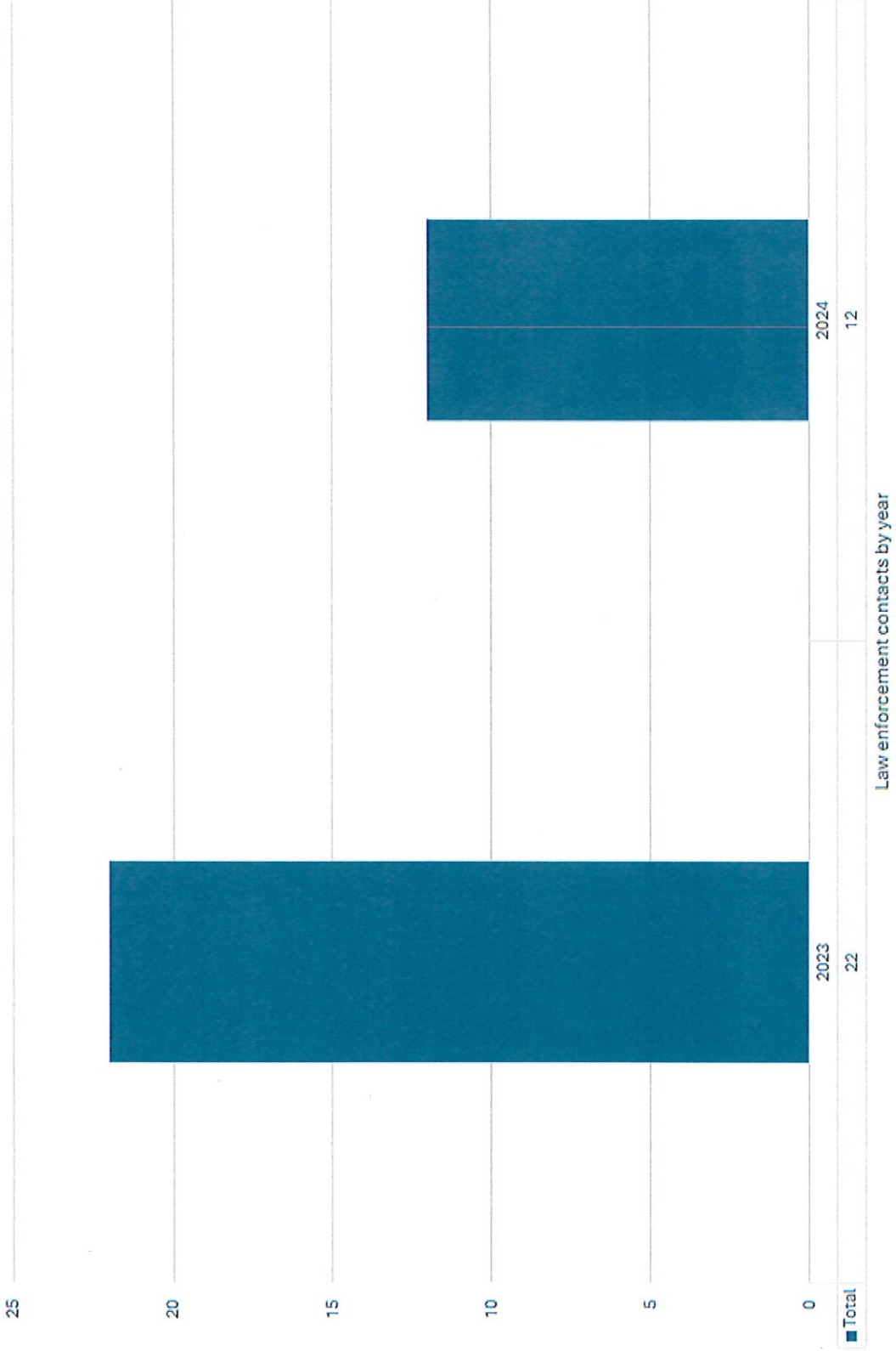


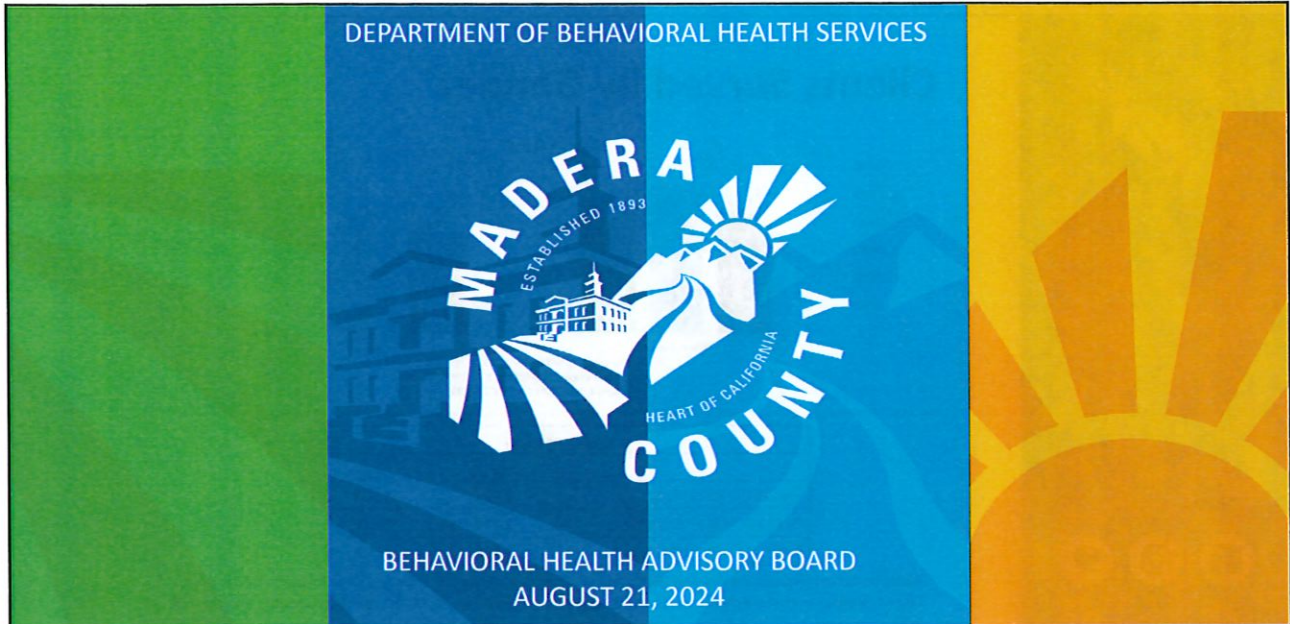
Law enforcement contact by month



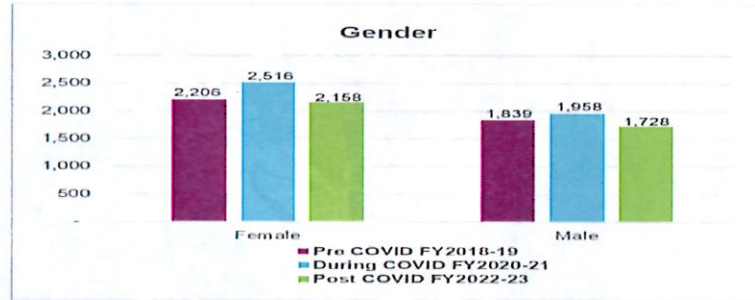
Analysis: The number of unique MH Clients Served peaked by 429 During COVID and decreased by 588 post COVID. This correlates with an increase in phone and telehealth contacts during the same time period (see table 8).

Next Steps: Use Clients Served (Demographics) report to identify trend changes and better inform system changes to include strategies for outreach, access, and staff capacity.

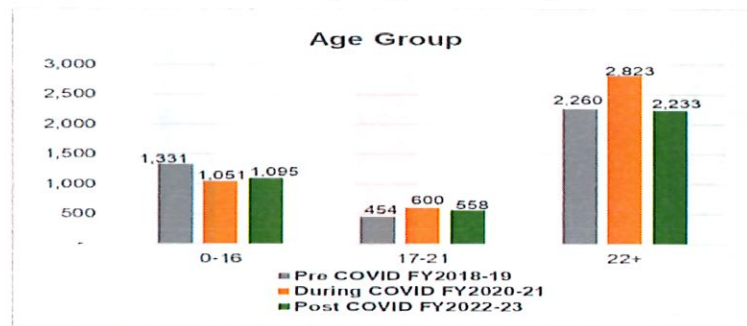
Analysis: Data shows a strong ongoing trend of a higher number of females entering into services vs. males. As in Table 1, a higher number of clients were served, regardless of gender during COVID. It can be deduced that the shift in how services were provided during COVID brought about an increase in those accessing services. It could be that the ability to receive services while at home with complete privacy made receiving services more feasible.

Next Steps: Use Demographics report to identify trend changes and better inform system changes to include strategies for outreach, access, and staff capacity.

Analysis: Data supports an incongruence with prior tables with 280 less clients in the age 0-16 accessing services during COVID while those of age 17-21 increased slightly by 146 clients served and those age 22+ being the most comfortable in accessing services during COVID with an increase of 563 additional clients served during this period.

Next Steps: Continue outreach services within the community and establish a plan to disseminate information about how to access mental health services to the public.

Clients Served by City of Residence

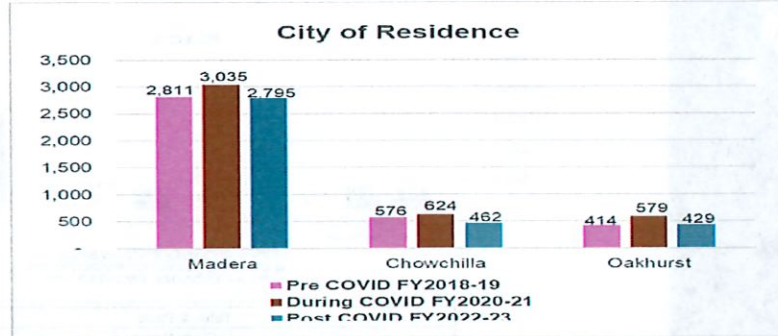

Analysis: A consistent trend continues supporting that a higher number of clients accessed and were served during COVID as opposed to pre and post COVID. Table 5 shows this number by city with the highest number of clients being seen in Madera vs. the other two more rural locations. Data shows an increase of 224 clients served in Madera, 48 increase in Chowchilla, and a 165 increase in Oakhurst as opposed to pre COVID.

Next Steps: Continue recruiting efforts to allow for appropriate providers to be available at each clinic site. Continue incentivizing hard to fill positions in the most rural areas of the County.

Clients Served by Ethnicity

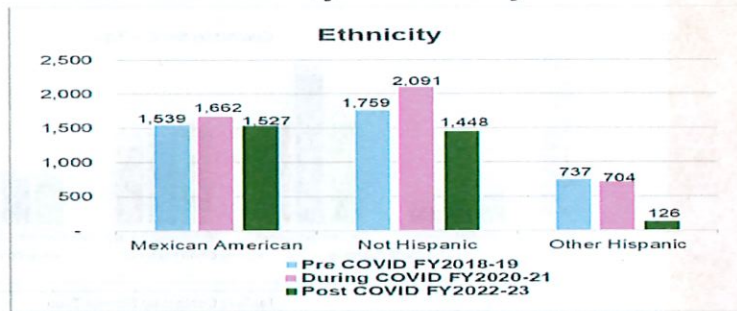

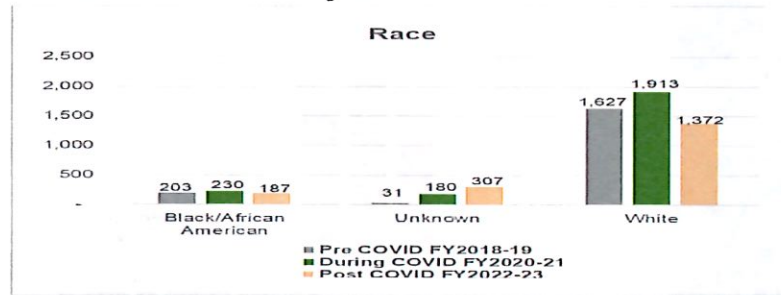
Analysis: Data clearly shows a higher number of Hispanic clients being served in all three FY measures with a marked difference between Hispanic and Not Hispanic groups in FY18.19 with a difference of 517 clients served. This was followed by a 275 difference in FY20.21 and a 205 difference in FY22.23.

Next Steps: Use Demographics report to identify trend changes and better inform system changes to include strategies for outreach, access, and staff capacity.

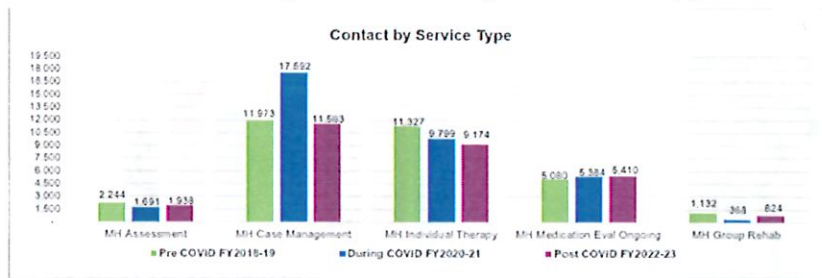
Analysis: As with prior tables, a consistent trend during COVID continues in the number of clients served by race. This is much more noticeable in the White population with an increase of 286 clients served during COVID when compared to Pre COVID. A much more conservative increase of 27 clients served during COVID is seen in the Black/African American population. Both groups see a marked decrease during Post COVID. Although the data shows an increase in those identifying as "Unknown" Post COVID, it's important to note this is due to our transition from one Electronic Health Record (EHR) to another and the difference in options available within each for race identification.

Next Steps: MCBHS' efforts for these two race groups as per EQRO, show is being effective, efforts will continue to ensure the community is aware of services offered and how to access them.

Clients Served by Contact by Service Type

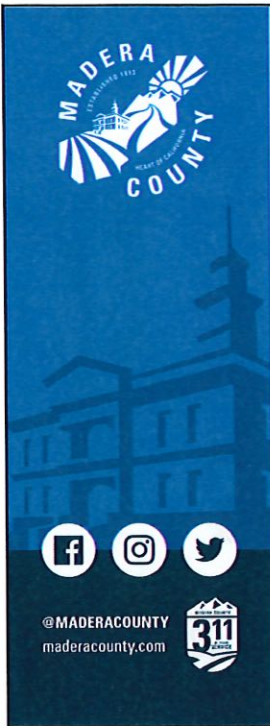

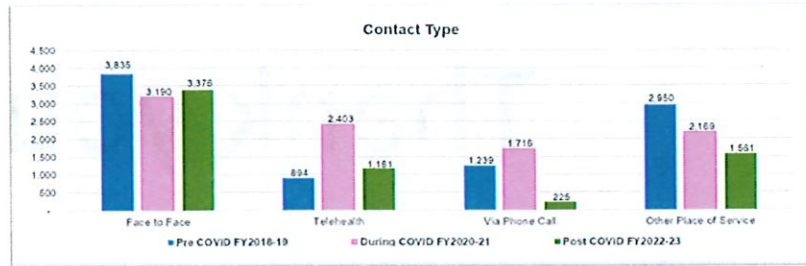
Analysis: When looking at specific services, we see that a higher number of assessments were conducted pre COVID with a decrease of 553 during COVID. This shows the hesitance clients felt in accessing services during COVID followed by an increase adjustment of 247 post COVID. A marked increase in case management coupled with a decrease in individual/group therapy and an increase in medication services shows the impact of COVID on the population we serve. There was a reliance on case management potentially for medication pickups, transportation to other vital medical appointments, or for food drop off at home.

Next Steps: Assess established recruitment strategies and their effectiveness to best determine if new strategies need to be developed to attract more applicants. As clients served numbers increase, reassess transportation unit and the need for additional drivers/vehicles.

Analysis: Table 8 shows a clear shift in how clients felt safest to attend services before, during, and after COVID. As no surprise, data supports a strong correlation between COVID and a decline in face to face (in-person) services. The data shows clients preferred to attend services via telehealth and phone during COVID followed by a sharp decline post COVID back to clients attending services in-person.

Next Steps: Use Demographics report to identify trend changes and better inform system changes to include strategies for outreach, access, and staff capacity. Develop and add informational material at Intake to inform clients of appointment options.



Recommendations

- Ensure the public and existing clients are informed at time of intake of their appointment options, 1) in-person (face to face); 2) Telehealth; 3) Phone; and 4) Other Place (as applicable). Potentially expand on the benefits each of the appointment options bring, such as removal of barriers like transportation and complete privacy as services are accessed from a computer or via phone.
- The youth seem to rely on social media to access information in general, it is recommended, strategies are developed to reach out to this group through social media and other web-based efforts for access at the touch of a finger. It is further recommended additional efforts be made to reach out to the parents of those age 0-16 specifically to ensure parents are aware of the supports available to their children. Said efforts should be made through social media and radio to capture a larger audience.
- Ensure each clinic has enough providers to include bi/lingual/cultural providers to serve the local population in a timely manner. Continue outreach efforts in rural areas of Madera to inform the community of the valuable services MCD BHS offers.
- Although more Hispanic clients were served in comparison to those who identify as Not Hispanic, efforts to inform the community through outreach events is key in not only reaching all populations but also increasing our penetration rates which declined during COVID to more than 1% point below the small county standard as per the External Quality Review Organization (EQRO) and remained .45% lower than small county standard at the end of CY2022. Ensure enough bi/lingual/cultural providers are available to serve the Hispanic population on an ongoing basis.
- Continue outreach efforts within the community and develop strategies to engage different race groups in the way they are most comfortable. It's important to note that at the end of CY2022, MCD BHS had a penetration rate of 8.25% for the African American population which is 1.93% higher when compared to other small counties in the state. For the white population, MCD BHS had a penetration rate of 6.36% which is 1.21% higher than other small counties in the state.
- Continue to share information about MCD BHS' transportation services to remove any existing transportation barrier from access to services. Continue recruiting providers to ensure Individual Therapy appointments are accessible in a timely manner.

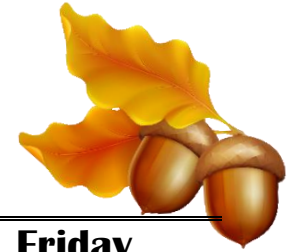

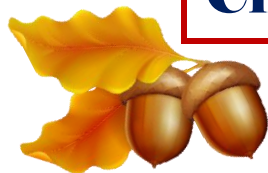

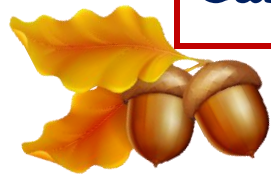
