DIRECTORY OF SERVICES

Behavioral Health Services in Madera 559-673-3508 209 E. 7th Street, Madera, CA

The following programs/services are located at this facility:

- Administration: BHS Administrative, Fiscal, Accounts Receivable, Contract Services, Data Management, Personnel, Purchasing, Transportation and other support services. Compliance & Privacy, Quality Management, Cultural Competency and MHSA Services, including PEI (Prevention & Early Intervention) and WET (Workforce Education & Training).
 Substance Abuse Services: Outpatient prevention and
- treatment programs for adults and juveniles with substance abuse problems. Services include individual, family and group counseling, some group counseling services offered during the evening. The Felony Drug Court program provides substance abuse offenders with resources and treatment to reduce the negative results of addiction. The Perinatal Substance Abuse Program provides services and support designed specifically for women and families affected by alcohol and/or other drugs. Per regulation (45CFR 96.131(a)), preference in admission to treatment facilities is given to pregnant women who seek or are referred for and would benefit from services. Perinatal funded services admission priority is given in the following order:

1. Pregnant Injection drug users;

2. Pregnant substance users;

3. Parenting injection drug users; and

4. Parenting substance users.

Outpatient Mental Health Services: Serving children, adults and families, including Dually Diagnosed individuals and MHSA Children/Youth, TAY, Adult & Older Adult Full Service Partnership clientele. Also at this location are the Infant Toddler Program, a collaborative, interagency program that provides assessment and intensive intervention services to children 0-5 and their families; and Foster Care Youth Services, a multiagency program that provides services for foster children. Parenting classes, some of which are open to the community, are offered in both Spanish and English. The Medical Director, Psychiatry/Telepsychiatry services and Crisis services are also at this facility.

 Madera Access Point (MAP) – CalWORKS: A collaborative program providing counseling, employment development services and additional support/educational groups for CalWORKS participants with identifiable barriers of mental health, substance abuse, and domestic violence issues. Outpatient mental health services for children, adults, families and outpatient substance abuse services. An on-site psychiatrist is available on Fridays.

Oakhurst Counseling Center 559-683-4809

Outpatient mental health and substance abuse services for children, adults and families, as well as crisis intervention services. Psychiatry services are available through Telemedicine. This clinic also offers an adult drop-in program called the Mountain Wellness Center that is open Tuesday thru Friday from 9:00 am – 4:00 pm and promotes a safe, nurturing environment that offers opportunities to develop and maintain optimal mental and emotional health.

BHS contracts with Turning Point to provide this MHSA funded PEI (Prevention & Early Intervention) center for adults. Countywide transportation is available to transport individuals to Hope House for participation in classes, support groups, and other activities.

Behavioral Health Board

This Board is comprised of members/volunteers from the community who are appointed by the Board of Supervisors and provides support, guidance, and direction to BHS.

Mental Health Services Act (MHSA)

MHSA services are county-wide and include intensive services for children, transitional age youth, adults, and older adults; Prevention & Early Intervention (PEI) services which include community drop-in centers in Oakhurst/Madera and parenting programs; social supports and services; outreach and engagement; and services for individuals who are traditionally unserved or underserved. Shared supportive housing is available in Madera and Chowchilla for Madera County residents who meet eligibility requirements.
